Motion: Cassandra Halls made a motion and Cindy Dietz seconded to give notice of intent to amend Chapter 62.


Vote: The ayes were unanimous. The motion carried.

Rules: Chapter 79 – Standards for Practitioner and Administrator Preparation Programs


Motion: Cassandra Halls made a motion and Cindy Dietz seconded to give notice of intent to amend Chapter 79.
