Industry-Recognized Credentials

What is an Industry-Recognized Credential?

An industry-recognized credential is a certification that has been widely acknowledged as holding value within a specific industry or field. Recipients of such credentials have demonstrated that they possess the knowledge, skills and competencies required to perform specific tasks or roles within that industry. IRCs are awarded by certifying bodies, trade associations or professional organizations that have established standards for proficiency and knowledge within that domain. Designated as a validation of an individual's expertise, IRCs serve as a trusted benchmark for employers and stakeholders.

Why are Industry-Recognized Credentials Important?

By earning an industry-recognized credential, individuals enhance their employability and professional credibility as well as their career advancement prospects. IRCs are developed in close collaboration with industry experts to ensure outcomes align with current and future job market needs. In offering IRCs, districts effectively equip students with specific in-demand knowledge and skills employers are seeking. Alignment of IRCs to district CTE pathways allows students to explore diverse career paths while gaining exposure to different industries and acquiring real-world skills and experiences that may help shape their career trajectories. IRCs can also foster stronger partnerships between districts and local businesses, community organizations and postsecondary organizations. These partnerships may help develop or strengthen increased collaboration in areas such as work-based learning (WBL) opportunities for students.

The Role of Industry Recognized Credentials and Education Pathways

Industry-recognized credentials help define structured program pathways for students and families. Many IRCs are stackable, meaning they can be accumulated and built upon over time. Students earning entry-level credentials may pursue additional related credentials as they progress through programs. In addition, certain IRCs have established pathways for college credit or articulation agreements with higher education institutions.

Characteristics of Quality Credentials

High-quality industry-recognized credentials possess key characteristics distinguishing them from other. Common characteristics of high-quality IRCs include:

- **Industry Recognition** – High-quality credentials are respected and recognized within the industry. They carry a strong reputation and are valued by industry experts, professional associations and employers.
- **Relevance and Currency** – Credentials are relevant to the current and future needs of the industry. They should align with industry standards, practices and emerging trends. High-quality credentials undergo routine updates to ensure they remain current and reflective of the evolving needs of the industry.
- **Rigorous Standards and Assessment** – Processes are in place to ensure credentials have clear expectations for the knowledge, skills and competencies required in the industry. Assessment methods are reliable, valid and comprehensive, ensuring individuals earning the credential have demonstrated proficiency. Credentials and their governance structure are accountable to their stakeholders and maintain transparency in their processes.
- **Advancement and Stackable Opportunities** – Credentials provide a clear pathway for career advancement and further education. They offer additional opportunities to higher-level credentials (stackability) and academic programs allowing individuals to continue their learning and advancement of knowledge and skills. Credentials are part of a structured framework that supports progression and portability across different organizations, regions and sectors. Transferability of credentials increases the value and versatility for individuals.
- **Alignment** – Credentials are clearly aligned to a CTE program of study.

Credential Evaluation and Approval Process

The Bureau of CTE and Postsecondary Readiness will maintain this evergreen document and the process of adding or removing credentials. Districts or community colleges seeking to add an industry-recognized credential for a secondary CTE course and/or program may submit a request using the following process. Credentials that are not demonstrated to be industry-recognized, current, valuable and supported by Iowa industry will not be considered. Credentials should meet all high-quality characteristics as outlined above and have the support of at least five Iowa businesses. While a credential does not guarantee employment, this list will provide support for high-quality credentials that can assist Iowans seeking employment by providing evidence of knowledge and skills relevant to the industry.

Credential Approval Process

Step 1 – Review of Institution and Quality Assurance

- Credentialing Institution Guidelines:
 - The district or community college submitting the credential for review has ensured that the institution providing the credential is in good national standing and has been third-party validated. There must also be evidence that the credential has clearly stated competencies, has high portability and stackability and the third party awarding the credential is transparent in regards to the assessment process, value to employers and performance needed to obtain the credential.
- Quality Assurance Guidelines:
 - The district or community college submitting the credential for review must show that it supports at least one of Iowa's CTE content areas, aligns with one of Iowa's high-demand industries and has the support of at least five Iowa employers who endorse it for hiring.

Step 2 – Submission of Application Form

All credentials being requested for review must complete the application form on the [Department website](#). This form is only available in the spring each year and must be completed in full to be considered.

Step 3 – Review and Response

- **Approval** – If the credential presented for review meets the high-quality criteria guidelines AND quality assurance guidelines, the credential will be approved and the list will be updated.
- **Pending** – If the credential meets one of the criteria, but not a second OR if there are sections of the application form the Department has questions about, the applicant may be asked to revise, clarify or expand upon the application form or meet directly with a portion of the Bureau team.
- **Denial** – If the credential submitted for review does not clearly meet the criteria guidelines, then the credential will be rejected.

Agriculture, Food and Natural Resources

Agriculture education prepares students for successful careers and a lifetime of informed choices in the global agriculture, food, fiber and natural resources systems.
