Kewe agency ren motor vehicle non state epwe fenini ngeni NDR ewe list ren aramas ren meinisin epwe chokor non driver privilege, me epwe fenini “hold” non mefen license. Ngeni ewe issuing ika reissuing ren driver’s license, ewe DMV non state epwe chok meiwei non registry; ika epwe chok meiwei ewe aramas, epwe fen ika epwe fen license.
