Minutes

October 10, 2025

The Board of Educational Examiners (Board or BoEE) held a meeting on October 10, 2025. Chad Janzen, Board Chair, called the meeting to order at 8:36 a.m. due to webinar technology issues. Members attending were Miranda Brus, Davis Eidahl, Eric St Clair, Dr. Michael Pyevich, Daniel Zylstra, Jennifer Sammons and Paige Thorson. Also in attendance was Mike Cavin, Executive Director, Beth Myers, Attorney/Investigator, Diane Dennis, Lori Lavorato, William Rector and Matthew Barron, Investigators, Lindsey Browning, Assistant Attorney General. Kathy Behrens and Pam Bleam were unable to attend.

Mike Pyevich moved, with a second by Paige Thorson, to approve the agenda. **MOTION CARRIED UNANIMOUSLY**

Paige Thorson moved, with a second by Jennifer Sammons to approve the consent agenda (minutes for September 12, 2025). **MOTION CARRIED UNANIMOUSLY.**

Eric St Clair moved, with a second by Miranda Brus, that the Board go into closed session for the purpose of discussing closed session minutes whether to initiate licensee disciplinary proceedings, the decision to be rendered in a contested case, confidential health information, and mental health information, pursuant to Iowa Code sections 21.5(1)(a), (d), and (f). 11 to object, retaining this pending licensing matter ensures that any potential threats or
12 risks to students are thoroughly evaluated while also guaranteeing the educator has
13 the opportunity to dispute the alleged ethical wrongdoing. **MOTION CARRIED**

16 Daniel Zylstra moved, with a second by Jennifer Sammons, to extend the 180-day
17 deadline for issuance of the final decision in **case number 25-114**, based the need to
18 schedule the hearing or negotiate settlement and conclude the contested case process,
19 and respondent does not object to the extension, dismissal of the case would
20 undermine public trust in educational licenses and would result in disparate
21 treatment of similar ethical violations. **MOTION CARRIED UNANIMOUSLY**

22
23 Mike Pyevich moved, with a second by Miranda Brus, to extend the 180-day deadline
24 for issuance of the final decision in **case number 25-117**, based the need to schedule
25 the hearing or negotiate settlement and conclude the contested case process, and
26 respondent did not file an objection to the extension even though given an opportunity
27 to object, dismissal of the case would undermine public trust in educational licenses
28 and would result in disparate treatment of similar ethical violations. **MOTION**
29 **CARRIED UNANIMOUSLY**

30
31 Jennifer Sammons moved, with a second by Paige Thorson, to extend the 180-day
32 deadline for issuance of the final decision in **case number 25-119**, based the need to
33 schedule the hearing or negotiate settlement and conclude the contested case process,

1 and respondent did not file an objection to the extension even though given an
2 opportunity to object, the Respondent would not be prejudiced by the additional time
3 necessary to resolve the pending complaint given that investigative information
4 remains confidential pending the final decision. **MOTION CARRIED UNANIMOUSLY**

5
6 Eric St Clair moved, with a second by Paige Thorson, to approve the closed session
7 minutes for September 12, 2025. **MOTION CARRIED UNANIMOUSLY**

8
9 Request for Reinstatement:

10 Case No. 22-186, In the Matter of Andrew Stoneking. Mr. Stoneking was alleged to
11 engage in inappropriate communication and interactions with students. Mr. Stoneking
12 received a sanction of: a reprimand, 3-year suspension starting November 29, 2022,
13 the ability to request deferral after 2 years and completion of the other requirements.
14 He was required to take an ethics course, boundaries class and undergo a risk
15 evaluation that included an assessment of his ability to establish and maintain
16 appropriate teacher/student boundaries and individual counseling. Mr. Stoneking
17 requested a deferred suspension previously but was denied. Mr. Stoneking believes he
18 has completed the requirements and submitted a request for reinstatement of his
19 license on November 29, 2025. Becky Knutson represents Mr. Stoneking and appeared
20 before the Board on his behalf. Miranda Brus moved, with a second by Paige Thorson,
21 that in **case no. 22-186**, the Board deny the application for reinstatement. While the
22 reason for the suspension no longer exists, reinstatement is not in the public interest.
23 **MOTION CARRIED UNANIMOUSLY.** The Board noted that Mr. Stoneking had not yet
24 met the timeline of the suspension and it would be willing to consider a future request
25 for reinstatement. The Board noted it would be helpful for any future request for
26 reinstatement include a recommendation from Mr. Stoneking's counselor that he was
27 ready to be around students, given the serious nature of the allegations.
