The State Board of Education hereby amends Chapter 41, "Special Education," and Chapter 120, "Early Access Integrated System of Early Intervention Services," Iowa Administrative Code.

Legal Authority for Rulemaking

This rulemaking is adopted under the authority provided in Iowa Code sections 256B.3.

State or Federal Law Implemented

This rulemaking implements, in whole or in part, 2025 Iowa Acts, House File 644.

Purpose and Summary

This rulemaking updates the State Board of Education's rules concerning the role of foster parents as special education decision-makers. This proposed rulemaking harmonizes provisions of 2025 Iowa Acts, House File 644, with federal law.

Public Comment and Changes to Rulemaking

Notice of Intended Action for this rulemaking was published in the Iowa Administrative Bulletin on October 1, 2025, as **ARC 9596C**.

A public hearing was held on October 21, 2025, at 9:30 a.m. at Room B50, Grimes State Office Building, Des Moines, Iowa, and by video conference.

No public comment was made at the hearing or otherwise received. Based on technical assistance received from the Iowa Department of Human Services, the text of the rule is revised for clarity.

Adoption of Rulemaking

This rulemaking was adopted by the State Board of Education on November 19, 2025.

Fiscal Impact

This rulemaking has no fiscal impact to the state of Iowa.

Jobs Impact

After analysis and review of this rulemaking, no impact on jobs has been found.

Waivers

Effective Date

This rulemaking will become effective on January 14, 2026.

 - ITEM 4. Amend paragraph 41.30(1)"e" as follows:
- . A surrogate parent, which may include a foster parent, who has been appointed in accordance with rule 281—120.422(34CFR303) or Section 639(a)(5) of the Act.
