Legislative Requirement

lowa Code 256.25 establishes the therapeutic classroom incentive grant program and department responsibilities. Therapeutic classroom grants are subject to annual legislative appropriation.

lowa Code 256.25A addresses therapeutic classroom claims requirements.

lowa Administrative Code 281.14.13 further defines the requirements of a therapeutic classroom for grants, claims and reporting purposes.

Therapeutic Classroom Grants

The Therapeutic Classroom Grant provides competitive grants to public school districts to establish therapeutic classrooms for learners ages 3 to 21 whose emotional, social, or behavioral needs interfere with their ability to be successful in their current educational environment

Public school districts may apply for the therapeutic classroom grant each spring subject to legislative renewal and appropriations. Iowa Code 256.25 specifies the priorities and funding formula for the grant process.

Therapeutic Classroom Grant Funds

The table below provides a summary of the number of districts and amount of grant funding distributed through the Therapeutic Classroom Grant process.

Therapeutic Classroom Claims

lowa Code requires an appropriation from the general fund to the Department in an amount necessary to pay all approved claims submitted for therapeutic services each year, beginning on or after July 1, 2022.

A school district that provides a therapeutic classroom according to approved requirements to students enrolled in a school district or an accredited nonpublic school may submit claims for students assigned to the therapeutic classroom who do not have an assigned weighting under section Iowa Code chapter 256B.9, subsection 1, paragraph "b," & "c," or "d," and for whom behavioral intervention plans have been implemented.

lowa Code 256.25A specifies the funding formula and process for claims.

Therapeutic Classroom Claim Funds

The table below provides a summary of amounts of claims by fiscal year. There were no eligible claims made for transportation to a therapeutic classroom in any year. No funding for therapeutic classroom transportation claims was appropriated for Fiscal Year 2026.

Therapeutic Classroom Requirements

A school district is not required to operate a therapeutic classroom; however, a school district is required to ensure therapeutic services are available, whether in-district or otherwise, to students who need those services to access or benefit from an education.

- Each fall, districts are required to sign assurances and report within the Consolidated Accountability and Support Application (CASA) the number of therapeutic classrooms they operate.
- Districts must report transfers and referrals to therapeutic classrooms using their student information system.

For state reporting and reimbursement purposes to be considered a therapeutic classroom the program/classroom must serve both students with and without IEPs and include all the components listed in Iowa Administrative Code 281-14.13
