Recommendation: It is recommended that the State Board approve the Array Global application as a “reliable authority concerning the quality of education” and grant the agency authority to accredit nonpublic schools in the state of Iowa.

Background: A nonpublic school may be accredited by an independent accrediting agency that appears on a list maintained by the State Board. The list shall include accrediting agencies that, as of January 1, 2013, accredited a nonpublic school in this state that was concurrently accredited under this section; and any agency that has a formalized partnership agreement with another agency on the list and has member schools in this state as of January 1, 2013. Five agencies met this standard at the enactment of these rules:

- Independent Schools Association of the Central States (ISACS)
- Christian Schools International (CSI)
- Cognia (formerly AdvancEd)
- The National Lutheran Schools Association (NLSA)
- The Association of Christian Schools International (ASCI)

Four agencies have been approved by the State Board:

- American Montessori Society (May 2014)
- Middle States Association-Commissions on Elementary and Secondary Schools (January 2024)
- Accrediting Commission for Western Association of Schools and Colleges (January 2024)
- Association of Classical Christian Schools (March 2024)

Array Global Accrediting Agency Application to Become an Approved Independent Accreditor

Background

Iowa Code section 256.11(16) grants authority to the State Board to maintain a list of approved independent accrediting agencies. Agencies on this list may accredit nonpublic schools.

Interested agencies are asked to apply for Initial Recognition as a Reliable Authority Concerning the Quality of Education Offered by a School to determine whether the organization is a “reliable authority concerning the quality of education” offered by an accredited nonpublic school.

The questions in the application have two purposes: (1) to determine the organization’s reliability in its accreditation authority, and (2) to determine the organization’s capability of helping schools maintain programs of acceptable quality. The deadline to apply to be an approved independent accrediting agency to be placed on the State Board approved list was September 2, 2025. The applicants were notified via email the application was received before the deadline and was under review.

Application Review Process

The application review process included two readers. Each individual read all applications and utilized the scoring matrix aligned to the application. After individual readers reviewed and scored each application independently, readers discussed the application and came to a consensus on the application’s scores. The scoring matrix below indicates the scores assigned to Array Global.

Section A. Organization Information	Handbook and Accreditation Report clearly describe accreditation process, and accreditation options. Array Global Accreditation is also approved by the National Council for Private School Accreditation.	32/32

Accreditation Standards	Standards and descriptions highlight requirements for accredited schools to obtain and develop quality staff, standardized assessment and plans for students needing extra support, corrective action process when standards aren’t met and fiscal, data and contract management requirements.	50/50
Section C. Accreditation Process	Process for accreditation is clearly articulated. Application lacked clear information regarding additional factors considered for accreditation, how Array Global evaluates their services and how schools choose or find the agency.	10/13
Section D. Organization Structure, Citations	No negative findings.	8/8 to -8
Section E. Additional Information (no points)	The agency currently accredits 40 schools within the U.S.	N/A
Final Applicant Score and Final Rationale (if appropriate)	Recommended for approval. Documentation provided supports that Array Global would meet the requirements to be a Reliable Authority Concerning the Quality of Education Offered by a School.	100/103

Recommendation

Array Global received a consensus score of 100 across the required components in the application. It is recommended that the State Board approve the Array Global to accredit Iowa nonpublic schools as stated in the Iowa Code section 256.11(16).
