lowa Community Colleges transmit fall enrollment data to the Department of Education after the 14th day of the fall term start date. All data included in this report, except where noted, are taken from the Management Information System (MIS) electronic data files and are confirmed by the community college.

Fall 2007 Iowa Community College Credit Enrollment

Fall 2007 unduplicated credit headcount enrollment of 87,072 demonstrates an increase of 2,111 (2.42%) over Fall 2006 unduplicated credit headcount enrollment of 84,961. See Table 1.

Fall 2007 Credit Hours

Fall 2007 credit hours equaled 823,602.45 hours, demonstrating an increase of 15,343.85 credit hours (1.86%) over Fall 2006 credit hours of 808,258.60. Students averaged 9.46 credits for the fall semester. See Table 3.




<u>Gender of Enrollees</u>: Consistent with national trends in postsecondary education, the majority of community college enrollees are female. (See Figure 2)

Age of Enrollees: Approximately sixty-nine percent (68.97%) of the total credit enrollment is 22 years or less, with 25.93 percent 17 years of age or under. The median age is 21. The age distribution is shown in Table 5. Table 6 shows Fall 2007 credit enrollee's average age of 22.55 continued a 5-year decline in average age.


Ethnicity of Enrollees: As shown in Table 7 below, minority enrollments at lowa's Community Colleges comprise 10.02 percent of the total enrollees that reported ethnicity. According to the 2000 census 7.4 percent of the general population in Iowa were minorities. Minority enrollments at Iowa's Community Colleges increased 6.37% (504) from Fall 2006 to Fall 2007.

Total Enrollment by Program Type: Community college fall credit enrollment continues to grow with approximately 58 percent (58.16%) pursuing Arts and Science programs (see Figure 3). Arts and Science program enrollment increased 1,734 (3.55%) from Fall 2006 to Fall 2007. Career Option programs increased 26 (0.49%) from Fall 2006 to Fall 2007. Career Technical enrollment increased 676 (2.27%) over the same time period. Combination of program type decreased 325 (-30.60%) during that time.


