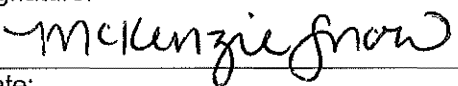

The Iowa Department of Education used three groups representing a broad spectrum of stakeholders. Each group meets regularly to discuss and develop priorities for the use of funds and the types of activities to be supported.

The Special Education Advisory Panel (SEAP) which has representatives from general education, private providers, parents, special educators, and other representatives of school districts held meetings in 2022-23 on 9/8-9/22, 10/14/22, 11/18/22, 1/3/23, 2/24/23, 3/31/23 and 5/12/23. During 2023-24 meetings have been held on these dates: 9/7-8/23, 10/13/23, 11/17/23, 1/12/24 and 2/23/24, with additional meetings currently scheduled for 4/5/24 and 5/10/24.

Representatives from all 9 intermediate units (Area Education Agencies) provide input and prioritize needs based on the activities to be supported in their agencies by Part B funds. This group includes the Area Education Agency's Chief Administrator, Director of Special Education, Director of Educational services, Area Education Agency School Business Official and Director of Media and Technology services. These meetings are held monthly or are scheduled on the fourth Thursday and Friday from August through May. Meetings during 2023-24 were held on 8/24-25, 9/14-15, 10/19-20, 11/15-16, 12/14-15, 1/18-19, 2/15-16, 3/21-22, 4/18-19 and 5/16-17. The 2022-23 meetings were held on or are scheduled for 8/25-26/22, 9/22-23/22, 10/20-21/22, 11/17-18/22, 12/15-16/22, 1/26-27/23, 2/23-24/23, 3/23-24/23, 4/20-21/23 and 5/18-19/23.

Additionally, the Department collects and leverages input on special education finance from school business officials and other administrators across school districts, AEAs, education associations and other education leaders. This group met on 10/25/23, 1/24/24 and 5/11/24.

The Iowa Department of Education staff combined the input from these broad-based stakeholder groups in a workable plan for the use of Part B funding in Iowa.
