

## Charter School Funding 2026-2027

### State Aid

Charter schools established pursuant to [Iowa Code chapter 256E](#) are funded by the state for each student enrolled in the year the student is served.

### Funding Amount

The amount generated for a charter school by each student attending includes the budget year state cost per pupil (SCPP) for the following amounts: regular program, teacher salary supplement (NEW FY27), teacher leadership supplement, professional development supplement, early intervention supplement, and, if applicable, any amount generated as a result of the non-English speaking weighting under section 280.4(3) (Iowa Code § 256E.8). Supplementary weighting generated for students in English Learner (EL) programs are determined by the student's English Language Proficiency Assessment (ELPA) score. EL weightings may be generated for up to five years for each student.

### Full-Year vs Partial-Year Enrollment

Students who are actively enrolled from the first day of school through the last generate the full amount of state aid. Students who either start after the first day of school or end before the last day of school are funded on a per diem (i.e., daily rate) basis using a 180-day denominator.

### Reporting and Payments

State aid payments are paid monthly September through June. The monthly payment dates are published on the Department's [State Payment Information](#) web page. Payments are calculated using enrollment numbers reported by charter schools from an initial enrollment reporting and three reconciliation periods.
