

IQPPS Implementation Support 2026-2027

The revised [2026 Iowa Quality Preschool Program Standards](#) (IQPPS) were approved by the State Board of Education on May 14, 2026. The revised program standards provide programs with a framework for fostering engaging learning environments, strong family partnerships, effective teaching practices and continuous improvement while reinforcing a statewide commitment to high-quality early childhood education.

Iowa programs operating Statewide Voluntary Preschool Programs (SWVPP), Shared Visions Preschool Programs (SV) and preschool classrooms providing Early Childhood Special Education (ECSE) services, are required to implement one set of State Board of Education approved preschool program standards. The Iowa Quality Preschool Program Standards are one option available.

Implementation of the 2026 IQPPS will begin on July 1, 2026, with statewide enactment expected by July 1, 2027. Given the similarity to the previous 2017 version, it is expected most programs will experience little to no disruption in implementation through the transition.

Desk audit items for the upcoming Universal Preschool Desk Audit will carry over to FY27. Items have been aligned to the 2026 IQPPS verbiage and numbering.

To support successful implementation of the revised standards, the Department will offer resources, professional learning opportunities and technical assistance to educators and administrators in the coming months.
