Senior Year Plus Faculty Background Investigation

Overview

Instructors employed by a community college who teach courses offered through Senior Year Plus (SYP) programs may be subject to criminal background investigation. This document contains guidance regarding the requirements of such investigations for lowa's community college state accreditation purposes.

Concurrent Enrollment

If a concurrent enrollment course is delivered at a school district's facility or a neutral site, the instructor must go through a criminal background investigation **prior** to providing instruction.

Per lowa Code 261E.3, subsection 2, paragraph "a", subparagraph (6):

If the instruction for any program authorized by this chapter is provided at a school district's facility or a neutral site, the teacher or instructor shall have successfully passed a background investigation conducted in accordance with [lowa Code] section 272.2, subsection 17, prior to providing such instruction. For purposes of this section, "neutral site" means a facility that is not owned or operated by [a school district or postsecondary institution].

An instructor employed by the school district may have completed this background check as part of the initial teacher licensure process.

If a course delivered at a school district's location or neutral site is taught by an instructor employed by the community college, the school district is responsible for ensuring the instructor has successfully passed the appropriate background investigation. Iowa Code 261E.3, subsection 3, paragraph k, states:

The school district shall ensure that the background investigation requirement of subsection 2, paragraph "a", subparagraph (6), is satisfied. The school district shall pay for the background investigation conducted in accordance with subsection 2, paragraph "a", subparagraph (6), but may charge the teacher or instructor a fee not to exceed the actual cost charged the school district for the background investigation conducted.

If a course is delivered at a college location and the instructor is employed by the college, the instructor is not subject to the background investigation requirement unless a background check is required by the college.

Background Investigation Components

The background investigation required of all secondary instructors and those instructors employed by a postsecondary institution instructing a course offered through concurrent enrollment which is taught at a school district's facility or neutral site is outlined in Iowa Code 272.2, section 17. The investigation shall include:

- A criminal background investigation conducted by the Division of Criminal Investigation, Department of Public Safety
- A completed fingerprint packet to be used to facilitate a national criminal history background check
- A review of the sex offender registry information under <u>lowa Code section 692A.121</u>, the central registry for child abuse information under <u>lowa Code chapter 235A</u>, and the dependent adult abuse records under <u>lowa Code chapter 235B</u>

Postsecondary Enrollment Option

Because all courses offered through Postsecondary Enrollment Option (PSEO) are offered at a postsecondary location, instructors employed by the postsecondary institution assigned to teach a course through PSEO are not required to undergo the criminal background investigation required of secondary instructors pursuant to lowa Code 272.2, section 17. Instructors shall comply with any criminal background investigation which may be required by the postsecondary institution.

Licensure Requirements

The instructor of any course offered through concurrent enrollment or PSEO, regardless of where the course is delivered, shall not be under suspension or revocation of a Board of Educational Examiners' (BOEE) license or statement of professional recognition (SPR) at the time of instruction. Per Iowa Code 261E.2, paragraph "e":

An individual under suspension or revocation of an educational license or statement of professional recognition issued by the board of educational examiners shall not be allowed to provide instruction for any program authorized by the chapter.

BOEE maintains a <u>Faculty Qualification Guide</u> of instructor credentials which is available on their <u>website</u>.

Accreditation Requirement

While the community college is not required to fulfill the criminal background investigation requirement, colleges are expected to collaborate with the school districts in their region to develop a procedure for ensuring the appropriate background investigations are conducted and that, in the event there is a suspension or revocation of licensure, it is shared with the community college. To this end, the college shall submit evidence indicating the college has communicated these requirements to the school district and established an appropriate procedure.
