



Transfer of Rights: Explanatory Charts

October 2015

Introduction

When a student with a disability attains the age of majority under state law, or is incarcerated, many rights under the Individuals with Disabilities Education Act (IDEA) transfer to the student. In some cases, IDEA rights do not transfer to the student but are retained by the student's parents or held by a third person. These charts help explain what rights transfer upon the age of majority. To select the correct chart, answer the following questions and work through the decision tree.
