Description

A Wellness Policy and Evaluation is in place; written goals for Nutrition Education and Promotion, Physical Activity and School Based Activities to Promote Wellness.

A written procurement plan for school nutrition has been developed. A Procurement Code of Conduct from the Diocese of Des Moines includes conflicts of interest and disciplinary actions. Director attended a regional training on Procurement. Plan to review and update plan annually and continue efforts to organize documentation of procurement events, including a log of annual micro and small purchases made for school nutrition program.

Civil Rights poster is displayed. Annual training is provided to staff as required. Written materials include the USDA Non Discrimination Statement. No discrimination observed.

Free and Reduced Meal applications are completed correctly; the current application is used, direct certification is utilized by using the E Look Up system; and denied applications were correctly determined. Applications are maintained with ICAVES and a copy of letter sent to household. Eligibility is kept confidential. The SFA has a back-up system for benefit issuance documents and system.

FSD does an excellent job with menu planning. Menu meets meal pattern requirements, offers variety; including many fresh fruits and vegetables, hummus offered as a dip to carrots regularly. Condiments controlled. Excellent documentation is maintained for meal pattern crediting and solid understanding by all nutrition staff. Thoughtful decisions are made with student nutrition, health and acceptability of menu in mind.

No fiscal action as result of this administrative review.

Nutrition Program is self-supporting. Director completed the Financial Report in IowaCNP as required. A meal charge policy is in place and communicated in student/parent handbook.

Site - Level Commendations Holy Trinity School (8119)

Description

A Food Safety Plan is in place and has been updated. Director and staff are maintain ServSafe Certification.

All meals observed during the day of the review met reimbursable requirements.

Nutrition environment is positive. A sample tray is displayed showing the menu for the day. Offer versus Serve allows students to decline items they would otherwise waste. Excellent signage for breakfast and lunch communicates how to build a meal. Nutrition program is well-marketed with a menus posted in a variety of locations. Nutrition staff are helpful and knowledgeable of meal pattern. Students are observed to have enough time to eat.

Smart Snacks – A process is in place for students in grades 2 - 8 may purchase a la carte items after they've eaten lunch. There is a Closed vs Open sign. Nicely organized and marketed to students separate from the a la carte line. Documentation is in place. All items are compliant. Smart Snacks are offered to parents to purchase for classroom parties.

Special Diets are accommodated and documentation is maintained.

Water is offered at breakfast and lunch as required.
