Addendum M: FTE Guide

Full-time equivalency (FTE) is the proportion of time for which a student is expected to attend compared to the total possible attendance in a school year. FTE **does not** always equate to Certified Enrollment Weighting. This document will provide guidance for the different types of enrollments and how to calculate the FTE for specific situations.

If the FTE of a student changes throughout the school year but the building remains the same, the enrollment of the original FTE should be ended with the exit code "14" (end or change enrollment). The student is then re-enrolled with the new FTE.

Preschool Students

 Preschool (PK) students should have an FTE reflecting the portion of the day they are expected to be in attendance. To calculate this FTE, divide the number of hours the student meets each week by the total number of elementary contact hours per week.

* The FTE for these students is determined by the portion of the school year your district is serving these students. The FTE for students who are dual enrolled and HSAP should be for time the student is attending classes, do not include the contact minutes for HSAP visits.

For elementary students, that would equate to the number of minutes a student is being served per week divided by the total number of instructional minutes per week.

- Elementary student attends a music class which meets twice a week for 30 minutes. The elementary school has 390 minutes each day.
 - Student served minutes per week/total instructional minutes each week = 0
 - (30 * 2) / (390 * 5) or 60 / 1950 = 0.03 FTE
- Elementary nonpublic student attends the first period of each day at the public school for a reading course. The class meets for 60 minutes each day and the school has 390 minutes in each school day. 0
 - Student served minutes per week/total instructional minutes each week =
 - (60 * 5) / (390 * 5) or 300 / 1950 = 0.15 FTE

For high school students, FTE equates to the number of courses scheduled as a portion of all possible periods, except for students enrolled in concurrent enrollment courses.

- High school student A attends your district for an FCS class that meets every period for 1st semester. The school has 8 periods each day, each semester, equaling 16 possible periods a year. This student's FTE would be 1/16 = 0.06
- High school student B attends your district for an Algebra I that meets one period all year long. • The school has 8 periods each day, each semester, equaling 16 possible periods a year. This student's FTE would be 2/16 = 0.13
- High school student C attends your district for an Auto class and a Welding class offered for dual • enrollment credit. Refer to the SCED Code and Contact Minutes document to obtain the contact minutes for the community college courses. The Auto course has 7200 contact minutes and the Welding class has 1600 contact minutes. Based on your district's Spring BEDS report, your district has 57,600 contact minutes for the school year.
 - 7200+1600=8800/57600=0.15 FTE

***The FTE for these students equates to the minutes the student is served each week divided by the total instructional minutes in a school week.

• Student receives instruction from a special education teacher for 90 minutes each week in the student's home. 90 minutes of contact/1950 total minutes of instruction in a week = 90/1950 = 0.05
