Purpose

The Standards Progression Tool provides a vertical view of the Iowa Academic Standards for English Language Arts (2024). Initially developed and adapted from a version by North Carolina in 2020, this tool has been updated by the Iowa Department of Education to align with the 2024 Iowa Academic Standards for English Language Arts.

This resource allows educators to see how each standard changes and builds from grade-to-grade as they progress towards career and college readiness. By using the vertical progression, educators are able to determine if instruction is aligned to grade-level expectation.

Reading and Writing Standards: Foundational Skills (K-5)

Print Concepts

RF.K.1 Demonstrate understanding of the organization and basic features of print.

- a. Follow words from left to right, top to bottom, and page by page.
 - b. Recognize that spoken words are represented in written language by specific sequences of letters.
 - c. Understand that words are separated by spaces in print.
 - d. Recognize and name all upper- and lowercase letters of the alphabet. (DOK 1)

- a. Recognize the distinguishing features of a sentence (e.g., first word, capitalization, ending punctuation). (DOK 1)

Phonological and Phonemic Awareness

RF.K.2 Demonstrate understanding of spoken words, syllables, and phonemes (sounds).

- a. Count, produce, blend, and segment syllables in spoken words.
 - b. Blend and segment onsets and rimes of single-syllable spoken words.
 - c. Isolate and pronounce the initial, medial vowel, and final phonemes (sounds) in three-phoneme (consonant-vowel-consonant, or CVC) words. (This does not include CVCs ending with /l/, /r/, or /x/.)
 - d. Add or substitute individual sounds (phonemes) in simple, one-syllable words to make new words.
 - e. Recognize and produce rhyming words. (DOK 1,2)

RF.1.2 Demonstrate the ability to identify and manipulate individual sounds in spoken words.

- a. Distinguish long from short vowel phonemes (sounds) in single-syllable words.
- b. Orally produce single-syllable words by blending phonemes (sounds), including consonant blends.
- c. Isolate and pronounce initial, medial vowel, and final phonemes (sounds) in spoken single-syllable words.
- d. Segment spoken single-syllable words into their complete sequence of individual phonemes (sounds). (DOK 1,2)

Phonics and Word Recognition

RF.K.3 Know and apply grade-level phonics, which includes word analysis skills to support decoding and encoding words.

- a. Demonstrate basic knowledge of phoneme-grapheme (one-to-one, letter-sound) correspondences by producing the primary and most frequent sounds for each consonant.
 - b. Associate the long and short sounds with common graphemes (spellings) for the five major vowels.
 - c. Read common high-frequency words with accuracy and automaticity (e.g., *the, of, to, you, she, my, is, are, do, does*).
 - d. Distinguish between similarly spelled words by identifying the sounds of the letters that differ. (DOK 1,2)

RF.1.3 Know and apply grade-level phonics, which includes word analysis skills to support decoding and encoding words.

- a. Decode and encode one-syllable words with common consonant digraphs.
 - b. Decode and encode regularly spelled one-syllable words with closed syllables and consonant blends.

 - d. Use knowledge that every syllable must have a vowel sound to determine the number of syllables in a printed word.
 - e. Decode two-syllable words following basic patterns by breaking the words into syllables (may include closed and open syllables).
 - f. With prompting and support, decode and encode words with inflectional suffixes (e.g., -ed, -ing, -s/es, -er).
