

Student Reporting in Iowa (SRI) Extract Specifications 2023-24

State ID Extract

Allows an LEA to assign Student State IDs and import them back into the Student Information System.

LEA Selection Options for Extract:

1. All active students
2. Active students without Student State IDs
3. Inactive students without Student State IDs

All three state ID extracts will follow the layout as described in the SRI 2024 Extract Order document. If **any** of the Legal Student Names are provided, populate with **all** Legal Student Names. If no Legal Student Names are provided, populate with Student Names. Note that the State ID Extract – Inactive contains a number of fields defaulting to null.

Record Types for the State ID Extract

- TH record: the first record in the extract (Transmission Header)
- ID record(s)
- TT record: the last record in the extract (Transmission Trailer)

Record Specifications for the State ID Extract

Each record is tab-delimited, terminated with a carriage return and line feed (ASCII 13 and 10). An example of a record is:

```
TH<0x09>02/25/2005<0x09>01:23:07<0x09>1234567890<0x13><0x10>
```

In the above example, <0x09> represents a tab, <0x13> and <0x10> represent the carriage return and line feed combination that make up an end-of-line marker.

When no data is present for a particular field, **do not** insert a blank space (ASCII 32) in the record. Simply follow the missing data with an immediate tab. For example, a record contains this data:

```
11<tab>22<tab>33
```

If the “22” was not present in the same record fragment, it would instead appear as:
11<tab><tab>33

The required fields and field sequence for each record type are contained in the SRI 2024 Extract Order document

Iowa Statewide Assessment of Student Progress Extract (ISASP)

Allows an LEA to send a file for the Iowa Statewide Assessment of Student Progress (ISASP).

- The file is to be comma separated file (CSV)
- The file is to include the Header Record as specified in the SRI 2024 Extract Order document

LEA Selection Options for Extract:

1. Active students in Grades 3-11 who entered the district after a specified date
2. All active students
3. User selected students (one or more)

EL Extract

Allows an LEA to send a file to the ELPA21 application to create student test records.

- The file is to be comma delimited (CSV).
- The file is to include the Header Record as specified in the SRI 2024 Extract Order document

LEA Selection Options for Extract:

1. Default: Active students in selected schools with an ELL Status of '1' Student in an English Language Instructional Program, '2' Identified as ELL but parent waived LIEP services or '8' Pending.
2. User selected students (one or more)

Record Specifications for EL Extract

Each record is comma-delimited (CSV), terminated with a carriage return and line feed (ASCII 13 and 10). When no data is present for a particular field, **do not** insert a blank space (ASCII 32) in the record. Simply follow the missing data with an immediate comma. Examples would be similar to the above with the substitution of "comma" for "tab".

Miscellaneous Notes

Default Values

User entry overrides the default. When the vendor uses a default either when creating a record, rolling data over, or when creating the extract, the value to use is listed. "No Default" means the user must enter a value and not the vendor.
