SCHOOL BUDGET REVIEW COMMITTEE Summary of Action March 15, 2022

The School Budget Review Committee met to hold hearings beginning at 10:00 a.m. on Tuesday, March 15, 2022, at the Department of Education, State Board Room, Second Floor, Grimes State Office Building, 400 E. 14th St., Des Moines, Iowa 50319-0146. Members of the Committee consist of the following: Department of Education Director Ann Lebo, Department of Management Director Kraig Paulsen, and public members: Leland Tack, Susan Battani, Keith England, and Mary Jo Hainstock. The director of the Department of Education is a non-voting member and the chair.

All decisions by the Committee shall be made in accordance with reasonable and uniform policies which shall be consistent with chapter 257. All such policies of general application shall be stated in rules adopted in accordance with chapter 17A. The Committee shall take into account the intent of chapter 257 to equalize educational opportunity, to provide a good education for all the children of Iowa, to provide property tax relief, to decrease the percentage of school costs paid from property taxes, and to provide reasonable control of school costs. The Committee shall also take into account the amount of funds available (257.31(10)). The SBRC shall review a school district's unexpended fund balance prior to any decision regarding unusual finance circumstances. The SBRC shall review a school district's unplemental amount under subsection 257.31(5).

B. Information Request Update: AEA Special Education Balance

During the December 14, 2021 SBRC hearing, the Committee requested from two AEAs, Heartland and Central Rivers, best practices related to their consistently low special education carryforward balance. The responses from both AEAs were presented to the SBRC at the January 25, 2022 hearing. Central Rivers was asked to provide additional detail. The follow-up letter from the district was provided.

C. TAG Districts and Budgets

As required by Iowa Code 257.45, the list of budget amounts for FY23 gifted and talented children program for each school district were provided to the SBRC. The amount provided in the DCPP will be \$69 with an estimated required local match of \$23 from the regular program district cost per budget enrollment. Amounts for FY23 were calculated based on a 2.5 percent SSA increase.

D. UAB Per Pupil Update

During the October 2019 work session, the committee discussed additional metrics to build a broader context of perceived levels of unspent authority. As a result of this conversation, state deciles (1-10) were established based on the most recent UAB Report published by the Department of Management. The version used for the calculations below was published January 25, 2022. A decile of 1 reflects the highest UAB per pupil values and a decile rank of 10 represents the lowest UAB per pupil values. The ranges of UAB per pupil in each decile were presented as provided below.
