# Reference Guide for Educator and District Staff Training and Professional Development

### **Required Training**

<u>lowa Code 256.9 subsection 67</u> directs the lowa Department of Education to develop and distribute to school districts a list of all professional development programs and other training programs in which employees of school districts are required to participate pursuant to federal law or state law, including <u>lowa Code 284</u>. The table provides a comprehensive list of required training in lowa Education Law, along with links to no-cost training options. Other agencies, such as the Occupational Safety and Health Administration, require training that is not included in this list.
