

from compulsory attendance law and the educational standards law for members of established religious denominations which profess tenets that differ substantially from these laws, and who have been in

existence for more than ten years.

Background: In the past, religious groups in lowa are exempt from the

compulsory education and school standards laws under lowa Code section 299.24. A one-year renewal of the initial two-year exemption may be requested annually by each religious group desiring to do so. These renewal

requests may be granted by the Director of the

Department of Education, with the approval of the State

Board of Education

Ten religious groups have submitted requests including an appropriate list of names, ages and post office addresses of children of compulsory age as required by lowa Code section 299.24.

Each of these religious groups has complied with requests for information.
