

Dear Director Snow:

I am writing to you on behalf of Northwest AEA to request permission, in accordance with subsection 273.3(7) of Iowa Code, to lease a portion of our main office at 5800 Discovery Blvd, Sioux City, Iowa to Western Iowa Tech Community College for their new Aviation Maintenance program.

The largely unfinished North wing of our new office building is currently underutilized and would be an ideal location for the new program offered by Western Iowa Tech Community College. They would like to lease up to 15,000 square feet of space on a 10-year initial lease.

Our building is located across the street from the new Oracle Aviation building that will house the Morningside University aviation program at the Sioux Gateway Airport. The two new programs being offered by WITCC and Morningside have the strong support of the City of Sioux City, the Airport Board of Trustees, and the 185th Refueling Wing - a unit of the Iowa Air National Guard.
