

**Recommendation:** It is recommended that the State Board approve the

amendments to the Choice Charter contract.

**Background:** Choice Charter School seeks to amend the contract by

requesting a waiver for Iowa Code 256.11 subsection 5: Educational standards, removing an Educational Service

Provider, and adding grades 7-8. The need for the requested changes to the contract; which include a waiver, grade spans, and the educational service provider, were not anticipated at the time of application and therefore not included in the approved application.

# FIRST AMENDMENT TO THE CHARTER SCHOOL CONTRACT BETWEEN CHOICE CHARTER SCHOOL AND THE IOWA STATE BOARD OF EDUCATION

WHEREAS the Choice Charter School ("Charter School") and the Iowa State Board of Education ("State Board") entered into a Charter School Contract on or about April 20, 2022 ("Contract").

WHEREAS, pursuant to said Contract, any Amendment must be in writing and executed by both the Charter School and the State Board.

WHEREAS, the Charter School will no longer be utilizing an Education Service Provider as originally set out in the Contract as of June 30, 2024 (end of fiscal year) and the Parties wish to amend the Contract to eliminate reference to same as of July 1, 2024.

WHEREAS, the Charter School sought and received an Offer and Teach pursuant to Iowa Code Section 256.11, of which such exemption and waiver is granted and documented via amendment to the Contract to provide for such exemption.

WHEREAS, the Charter School anticipates adding grades seven (7) and eight (8) within the next twenty-four months and the Parties wish to amend the Contract to provide for such expansion.

NOW THEREFORE, the Charter School and State Board agree and amend the Contract as follows:

- 1. Section II. On page 1 of the Contract is amended to include, at the end of Section II, the following: "Pursuant to Iowa Code section 256.11 the Offer and Teach Exemption is granted to Charter School as follows:
  - Grades 7-8:
    - o Career Education and Technology Education
  - Grades 9-12
    - Health Education One-half (1/2) unit namely the second unit, requirement is hereby waived, and Choice Charter School is granted an exemption from same.
    - o Math The 4<sup>th</sup> class in the sequence, specifically the 4<sup>th</sup> advanced unit requirement is hereby waived, and Choice Charter School is granted an exempt from same.
    - Career and Technical Education ("CTE") Choice Charter School is granted a waiver or exemption for two (2) strands, a waiver of the CSSO organizations that accompany its CTE, and a waiver of the CTE committee.
- 2. Section IV.E on page 3 of the Contract is stricken and removed from the Contract as of July 1, 2024.

- 3. Section I.A on page 3 of the Contract is revised to strike and remove the reference to "Education Service Provider" as of July 1, 2024.
- 4. Section I.C. shall be amended to add Annual Performance Targets, Indicators and Measures relating to Student Academic Proficiencies for grades 7 and 8 as follows:

# **Amendment to Charter Contract**

# Background

<u>lowa Code 256E</u> establishes a charter school law in lowa that affirms charter schools shall be a part of the state's public education system. In conjunction with lowa Code 256E, the lowa State Board of Education has also approved <u>lowa Administrative Rule Chapter 19</u>. Chapter 19 establishes specific application deadlines, additional performance criteria, and finance modifications for charter schools.

The Iowa Department of Education (Department) received a request by Choice Charter to amend the contract between Choice Charter and the Iowa State Board of Education.

### Contract Amendment Overview

During the 2023-2024 school year, Choice Charter requests to make changes to the original contract based on constituent needs. They seek to amend the contract by requesting waivers, removing an Educational Service Provider, and adding grades 7-8. Table 1 outlines the requested amendments. The initial approved application for Choice Charter School did not request any waivers and named Jordahl Academy as an Educational Service Provider.

# Recommendation

It is recommended that the State Board approve the amendments to Choice Charter's contract.

#### PROPOSED CHARTER SCHOOL CONTRACT - CHOICE CHARTER SCHOOL

THIS CHARTER SCHOOL CONTRACT ("Contract") for Choice Charter School, is authorized pursuant to Iowa Code Section 256E.6, and executed by and between the Iowa State Board of Education ("State Board") and Founding Group Choice Charter Schools, Inc. ("Charter School") on this 20th day of April, 2022.

#### RECITALS

WHEREAS, the Charter School is a Not-for Profit corporation organized under the State of Iowa who has applied as a Founding Group to become a charter school under Iowa Code section 256E.5.

WHEREAS, the application of the Charter School to become a charter school under Iowa Code Chapter 256E has been approved by the State Board pursuant to Iowa Code Chapter 256E.

WHEREAS, the name of the school shall be Choice Charter School.

WHEREAS, pursuant to Iowa Code section 256E.6, upon approval of a Charter School Application, the parties are to execute a Charter School Contract (hereinafter "Contract").

WHEREAS, Choice Charter School, Inc. is authorized to execute this Charter School Contract pursuant to its Bylaws and the laws of the State of Iowa.

WHEREAS, The Iowa State Board of Education is authorized to execute this Charter School Contract pursuant to Iowa Code Chapter 256E.

NOW, THEREFORE, the parties hereto, intending to be legally bound by the terms and conditions set forth herein, enter into this Contract:

- I. <u>Recitals.</u> The Recitals are expressly adopted by the Parties as part of the terms and conditions of this Contract.
- II. Authority. The State Board hereby authorizes the Charter School, as a Founding Group, to operate as a charter school under Iowa Code Chapter 256E and that such Charter School shall be known as Choice Charter School and shall have the authority and power to carry out the purposes and powers provided for charter schools established by Founding Groups under Iowa Code Chapter 256E. The Charter School shall be subject to the applicable laws of the State of Iowa including those governing charter schools under Iowa Code Chapter 256E as well as Iowa Civil Rights Act (Iowa Code Chapters 216 and 216A), the Federal Civil Rights Act of 1964, state and federal anti-discrimination laws, Iowa Code Chapters 22 (Freedom of Information Act), 256B (Special Education), 256E (Charter Schools), and 272 (Education Examiners Board) where and when applicable, Iowa Code sections 11.6, 11.14, 11.19, 279.29, and 256.9(20) pertaining audits unless deviations allowed/approved by the State Board of Education, Iowa Code section 279.10(1) relating to instructional hour/day requirements unless waived by the State Board of Education.

III. <u>Duration</u>. The initial term of this contract shall be five (5) school budget years beginning at the school budget year of 2022/2023, and ending at the conclusion of the 2026/2027 school budget year. The opening of the Charter School shall be July 1, 2022. The ending of the Charter School contract shall be June 30, 2027. 281-19.9(1)

#### IV. Designation of Roles.

- A. Charter School. The "Charter School" is Choice Charter School, Inc. which is a Not-for-Profit corporation organized under the laws of the State of Iowa which applied as a Founding Group to become a charter school pursuant to Iowa Code section 256E.5. By and through its Governing Board (or Founding Members until the Governing Board is established and has met), the Charter School shall have the power to carry out the general and specific purposes of the Charter School as set forth in its Bylaws including, but not limited to, the authority to carry out all acts necessary to achieve one or more of the purposes set forth in Iowa Code section 256E.1(3) including, but not limited to, improving student learning, wellbeing and postsecondary success; increasing learning opportunities of students in areas of need; increasing opportunities for serving at-risk populations; implementing a multitiered system of supports for students; and allow greater flexibility to meet the educational needs of a diverse student population. The authority of the Charter School shall be limited only by the Bylaws and the applicable laws, rules and regulations of the State of Iowa.
- B. Founding Members. The "Founding Members" of the Charter School are Dr. Cynthia Knight (Union, IA), Jerry Homeyer (Aurora, CO), Craig Elliot (Los Gatos, CA), Jennifer Sayers (Des Moines, IA), Steve Cox (Union, IA) and Janet Merry (Granger, IA). The Founding Members shall have the authority to take action or assist in taking necessary action to establish the Charter School, obtain application approval for the Charter School; set the initial policies and goals of the Charter School; elect the initial Board of Directors; establish policies that shall govern the Board of Directors; and undertake and/or assist with the general powers as set forth the Charter School Bylaws until the Board of Directors is established and can take over same. The authority of the Founding Members shall be limited only by the Bylaws and the applicable laws, rules and regulations of the State of Iowa.
- C. Governing Board. The initial "Governing Board" of the Charter School are Trent Grundmeyer (Huxley, IA), Aundra Meeks (West Des Moines, IA), Tara Andrews (Des Moines, IA), LaWanda Sanders (Des Moines, IA), Andy Mogle (Urbandale, IA) and a student representative. The Governing Board shall have the authority to manage and carry out the business and affairs of the Charter School and to exercise all of the powers that may be exercised by the Charter School including, but not limited to, the duties set forth in Section V, below, as well as oversight of any Education Service Provider and/or Chief Administrative Officer. The authority of the Governing Board shall be limited only by the Bylaws and the applicable laws, rules and regulations of the State of Iowa.

- Chief Administrator. The initial "Chief Administrator" of the Charter School is Dr. Cynthia Knight. Subject to the oversight of the Governing Board (or Founding Members), the Chief Administrator shall be responsible for the general day-to-day administration of the Charter School as well as educational programing, oversight, and management of teachers, staff and other administrators, oversight of students, and all other administrative duties necessary for the carrying out of the day-to-day operation and fulfillment of the purpose of the Charter School as well as the facilitating and implementing the decisions of the Governing Board. The Chief Administrator shall be a non-voting member of the Governing Board and may be subject to the terms and conditions of any written agreement between the Chief Administrator and the Governing Board as well as the Bylaws of the Charter School.
- E. Education Service Provider. The initial "Education Service Provider" is Net High Academy/Don Jordahl Youth Enhancement Fund d/b/a Jordahl Academy, an Iowa Not-for Profit Corporation. Subject to the oversight of the Governing Board, the Education Service Provider has the authority to provide and perform services regarding or relating to the carrying out of the educational program implementation and comprehensive management services of the Charter School, including those set forth under Section V, below, as an Education Service Provider under the oversight of the Governing Board and the Chief Administrator and pursuant to written agreement between the Education Service Provider and Governing Board.
- **F.** <u>State Board</u>. The "State Board" is the Iowa State Board of Education. The State Board shall have the authority set forth under Iowa laws, statutes, rules and regulations.
- **G.** <u>Department</u>. The "Department" is the Iowa Department of Education. The Department shall have the authority set forth under Iowa laws, statutes, rules and regulations.

# I. <u>Duties of Charter School and Governing Board</u>

- A. <u>Duties of the Governing Board.</u> The roles and responsibilities of the Governing Board include the following and/or oversight of the Education Service Provider and/or Chief Administrator in performance of any or all of the following:
  - i. Recruiting, hiring, administration, oversight, development, and termination of teachers, administrators, faculty and staff of the organization and/or charter school
  - ii. Recruiting, enrolling, transferring students including, but not limited to, establishing procedures for conducting transparent admissions selections and lotteries
  - iii. Financial development and management
  - iv. Fiduciary Duties
  - v. General program oversight
  - vi. Coordination of long-term planning

- vii. Overseeing and evaluating the work of the Principal and Chief Administrator
- viii. Setting a framework for the budget process and authorizing the annual budget
- ix. Approving large resource expenditures, significant program changes, expansion into new program areas, and building and facility issues
- x. Adopting an annual budget
- xi. Locating new buildings or changing the location of the school's administrative offices
- xii. Creating or increasing indebtedness
- xiii. Adopting online and offline education programs and curriculums including utilizing existing or establishing new operations schedules, classroom sizes, learning environments, classroom structure, curriculum and teaching methods
- xiv. Obtaining, creating, managing and implementing academic and instructional programs and standards
- xv. Designating depositories of school funds
- xvi. On behalf of the organization, entering into contracts not previously approved in the annual budget and that involve funds in excess of \$5,000.00
- xvii. On behalf of the organization, entering into contracts with and making appropriations to the Charter School districts, professional service providers, or education service centers
- xviii.Using and measuring internal and external assessments of Charter School including, but not limited to, measuring and reporting student progress and performance in accordance with Iowa Code section 256E.9
- xix. Utilizing existing or creating and carrying out plans for identifying and serving students with disabilities, students who are limited English proficient, students who are academically failing or below grade level, students who have dropped out of school previously, are at risk for dropping out, have been expelled, and gifted students
- xx. Utilizing existing or establishing and carrying out cocurricular and extracurricular programs as necessary
- xxi. Preparing a student code of conduct with disciplinary procedures and sanctions
- xxii. Utilizing existing or creating and establishing new performance evaluation measures, compensation structure, methods of contract oversight and dispute resolution, employment policies
- xxiii.Utilizing existing or establishing new and carryout plans for providing transportation services, food services and other operational and ancillary services
- xxiv. Prepare a school start-up plan and five-year plan for the Charter School
- xxv. Ensuring compliance with all applicable laws and regulations
- xxvi.Other matters necessary to carry out the purpose and vision of the Charter School.
- xxvii. Other responsibilities as deemed necessary or provided for by applicable law.

- **B.** Academic and Operational Performance Expectations. The Charter School shall ensure the following academic and operational performance expectations and meet all annual performance targets for the following:
  - i. Student academic growth and proficiency in English language arts on statewide outcome assessments.
  - ii. Student academic growth and proficiency in mathematics on statewide outcome assessments.
  - iii. Achievement gaps in both proficiency and growth on statewide outcome assessments between specified populations or groups of students, including groups based on gender, race, poverty, special education status, limited English proficiency, and gifted status.
  - iv. Benchmark status on early literacy approved screening measure(s) in grades kindergarten through 3.
  - v. Attendance.
  - vi. Conditions for learning data (as required by Iowa's state plan under the Every Student Succeeds Act).
  - vii. Enrollment attrition and mobility.
  - viii. Postsecondary readiness for students in grades 9 through 12.
  - ix. Goals specified in the charter school's mission.
  - x. Financial performance and sustainability.
  - xi. Governing board performance and stewardship, including compliance with all applicable laws, regulations, and terms of the charter contract.

## E. Annual Reports.

By October 1st of each year the Charter School shall submit an annual report to assist the State Board in evaluating the Charter School's performance and compliance with the performance framework. The Annual Report shall meet all requirements set forth in Iowa Code Chapter 256E and Iowa Administrative Code 281-19.15, including:

**a.** The Charter School's mission statement, including a vision statement and goals, as well as data measuring goal attainment.

- **b.** Student demographics, disaggregated by grade level and protected characteristics.
- **c.** Attendance statistics and dropout rate (average daily attendance, dropout rate, student mobility).
- **d.** Graduation data, including four-year and five-year graduation rates, credit accrual, and number of students on track for graduation.
- e. Student achievement, including annual academic growth and proficiency, including Iowa statewide assessment of student progress (ISASP) data, other assessment data, and aggregate assessment test scores.
- f. Financial performance, including projections of financial stability.
- g. The number and qualifications of teachers and administrators.
- **h.** Sustainability data, including enrollment trends, staff satisfaction, and parent and student satisfaction.

By September 15th of each year, the Charter School shall submit a Certified Annual Report pursuant to Iowa Administrative Code Chapter 281-99.

#### VI. Duties of the State Board.

- A. <u>State Assessments</u>. The State Board is responsible for collecting, analyzing, and reporting all data from state assessments and other state data sources in accordance with the performance framework. All efforts shall be made by all parties to this contract to eliminate or reduce duplicative data reporting requirements.
- B. Monitoring. The State Board shall monitor the performance and compliance of the Charter School, including collecting and analyzing data according to this Contract in order to meet the requirements of Chapter 256E. Such monitoring shall not exceed the duties or powers set forth in this Contract or Chapter 256E nor shall such monitoring unduly inhibit the autonomy granted to the Charter School. Any performance report resulting from an inquiry or investigation under this rule shall, upon conclusion of such action, be included in the annual report required under Iowa Code section 256E.12.
- C. <u>Noncompliance or Unsatisfactory Performance</u>. If the Charter School's performance under the Contract or compliance with applicable laws or rules is unsatisfactory, the State Board shall notify the Charter School of the perceived problem and provide reasonable opportunity, which such reasonable opportunity shall not be less than sixty (60) days in duration, for the Charter School to remedy the problem, unless the problem warrants revocation, in which the revocation provisions in Iowa Code Chapter 256E shall apply.
- D. <u>Corrective Actions and Sanctions</u>. The State Board may take appropriate corrective actions or impose sanctions, other than revocation, in response to deficiencies in the Charter School's performance or compliance with applicable laws and rules. Such actions or sanctions may include requiring the Charter School to develop and execute a corrective action plan within a specified time period, which shall not be

- less than sixty (60) days.
- E. <u>Charter School Performance Report.</u> Annually, by June 30, the State Board shall issue a Charter School Performance Report. The Performance Report shall summarize the Charter School's performance record to date based on the data required by the Contract and Iowa Code Chapter 256E and shall identify concerns that may jeopardize renewal of the Charter School Contract if not remedied. The Charter School shall have sixty (60) days to respond to the Performance Report and submit any corrections or clarifications for the Report.
- F. <u>Notification of Department</u>. Within fifteen (15) days of execution of this contract the Governing Board shall notify the Department of Education and the Department of Management of the name of the Charter School, any applicable education service provider, the proposed location of the Charter School, and the Charter School's first year projected enrollment.
- VII. <u>Duties of the Department</u>. The department shall monitor the effectiveness of the Charter School and shall implement the applicable provisions of Iowa Code Chapter 256E and Iowa Administrative Code 281-19
- VIII. Renewal. This Contract may be renewed for periods of time not to exceed an additional five (5) years. If applicable, the Charter School may use the expedited renewal procedures provided for in Iowa Administrative Code 281-19.13(13). When the Term of this Contract is set to expire in the following school budget year, the State Board, by June 30<sup>th</sup>, shall provide a Charter School Contract Renewal Application Guidance to the Charter School. When the Term of this Contract is set to expire in the following school budget year, no later than October 1, the Charter School, through the Governing Board, shall submit a renewal application to the State Board pursuant to the renewal application guidance. A renewal or denial shall be approved by resolution of the State Board within sixty (60) days following the filing of the renewal application. The State Board shall carry out all responsibilities for renewal found in Iowa Administrative Code 281-19.13(9) or as required by Iowa Code Chapter 256E.
- IX. Revocation and Non-Renewal. This Contract may only be revoked or not renewed if the State Board determines that the Charter School did any of the following: (1) committed a material violation of any of the terms, conditions, standards, or procedures required under the Charter School Contract or Iowa Code Chapter 256E; (2) failed to meet or make sufficient progress toward the performance expectations set forth in this Contract; (3) failed to meet generally accepted standards of fiscal management; or (4) violated a provision of law from which the Charter School was not exempted. Such determination shall be by written resolution of the State Board and shall clearly state the reasons for the revocation or nonrenewal. Prior to such determination by the State Board, the State Board shall provide the Charter School with a notice of the possibility of revocation or non-renewal. The Charter School shall be allowed to respond to, contest or appeal the notice pursuant to the revocation and nonrenewal standards and procedures developed by the State Board. The Charter School

shall be provided an opportunity to submit documents and give testimony challenging the decision to revoke the Contract or the decision to not renew the Contract and shall be allowed the opportunity to hire legal representation and to call witnesses. Any proceedings held under this Section shall be allowed to be audio or video recorded.

- X. <u>Funding.</u> Fundings for the Charter School shall be provided, at least in part, pursuant to Iowa Administrative Code section 281-19.12.
- XI. <u>Amendment.</u> No amendments or additions to this Agreement shall be binding, unless in writing and signed by both parties, except as herein otherwise provided.
- I. <u>Headings.</u> The paragraph headings used in this Agreement are included solely for convenience and shall not affect, or be used in connection with, the interpretation of this Agreement.
- I. <u>Construction and Governing Law</u>. This Agreement shall be governed in all respects, whether as to validity, construction, interpretation, enforcement, capacity, performance, or otherwise, by the laws of the State of Iowa

# Choice Charter School Request for Offer and Teach Exemption Courses, Iowa Code section 256.11.

WHEREAS, Choice Charter School is a Charter School is an authorized Charter School under Iowa Code section 256E.6 and under contract with the Iowa State Board of Education and Choice Charter Schools, Inc. pursuant to Iowa Code chapter 256E, executed April 20, 2022.

WHEREAS, Choice Charter School seeks the Offer and Teach Exemption and Waiver for Online Courses as provided in Iowa Code section 256.11.

WHEREAS, Choice Charter School assures the Iowa State Board of Education as follows:

- 1. The provision of all courses via an online alternative are offered in one of the following ways:
  - a. The course is taught by an Iowa licensed teacher.
  - b. Choice Charter School provides the course in an online learning platform in a manner that meets the requirements of the rules for online learning passed by the Board;
  - c. Choice Charter School uses a private provider approved by the Department; or
  - d. Choice Charter School uses an online platform offered by the Department in collaboration with the AEAs and/or districts or nonpublic schools.
- 2. Pursuant to Iowa Code Section 256.11
- 3. Under Iowa Code section 256.11(4)/Iowa Admin Code R. 281-12.5 as it relates to Grades 7-8, Choice Charter School is seeking an exemption for Career and Technology Education (section 256.11(4)(j)&(k)), specifically it is seeking a waiver or exemption from the traditional six (6) strand model for CTE to give the students more flexibility for exploration in these grades. The target student for Choice Charter School are students who want a basic high school diploma and Choice Charter School will meet the needs of all students with regard to higher math, English, social studies, and sciences; however, a waiver allows Choice Charter School to serve students as they need to be served and does not force the students into classes they do not need or want.
- 4. Under Iowa Code section 256.11(5), as it relates to Grades 9-12, Choice Charter School is seeking an exemption for:
  - a. Health Education Choice Charter School is seeking a waiver or exemption for one-half (1/2) unit namely the second unit under section 256.11(5)(j).
  - b. Math Choice Charter School is seeking a waiver or exemption for the 4<sup>th</sup> class in the sequence, specifically the 4<sup>th</sup> advanced unit under section 256.11(5)(d).
  - c. Career and Technical Education ("CTE") Choice Charter School is seeking a waiver or exemption for two (2) strands, under section 256.11(5)(h), so that it may have more flexibility in providing career experiences to its students that are not siloed. It is requesting a waiver for the CSSO organizations that accompany its CTE. Choice Charter School is seeking a waiver or exemption

for the CTE committee because the statewide format has Choice Charter School looking for a community liaison and local job coaches.

- 5. Fewer than ten students typically register for each of the courses.
- 6. Choice Charter School's purpose includes improving student learning, wellbeing and postsecondary success; increasing learning opportunities of students in areas of need; increasing opportunities for serving at-risk populations; implementing a multitiered system of supports for students; and allow greater flexibility to meet the educational needs of a diverse student population. Its objective includes providing an opportunity for students who have dropped out or at risk of dropping out of school and to do so by providing an education that is done differently, namely through online courses, mentorship programs, career clusters, and other non-traditional learning opportunities. Choice Charter School seeks to honor the career dreams of the students by creating individual learning pathways toward post-secondary training, education, certifications, apprenticeships and jobs. Granting the exemption/waiver allows Choice Charter School to focus on the objectives, purpose and goals of Choice Charter School by allowing it to meet State requirements while providing alternative educational opportunities for the population of students at-risk of dropping out and/or those seeking a career focused or driven path post-graduation. Choice Charter School has met with and discussed the requested exemptions with representatives from the Iowa Department of Education and received and implemented the constructive recommendations from same in preparing this Request for Offer and Teach Exemption.

NOW THEREFORE, Choice Charter School respectfully requests it be granted the Offer and Teach Exemption and Waiver for Online Courses, pursuant to Iowa Code section 256.11, via amendment to the Contract between Choice Charter School and the Iowa State Board of Education, for the following courses:
