

Introduction

The Iowa Academic State Standards for English Language Arts & Literacy in History/Social Studies, Science, and Technical Subjects ("the Standards") are intended to ensure that all students are college and career ready in literacy no later than the end of high school.

The Standards draw on international models, research, and input from numerous sources, including state departments of education, scholars, assessment developers, professional organizations, educators from kindergarten through college, and parents, students, and other members of the public. In their design and content, the Standards represent the best elements of standards-related work to date.

The Standards are research and evidence-based, aligned with college and work expectations, and rigorous. A particular standard was included in the document only when the best available evidence indicates that its mastery is essential for college and career readiness in a globally competitive society.

The Standards set requirements for English language arts (ELA) and literacy in history/social studies, science, and technical subjects. Just as students must learn to read, write, speak, listen, and use language effectively in a variety of content areas, so too must the Standards specify the literacy skills and understandings required for college and career readiness in multiple disciplines. Literacy standards for grade 6 and above are based on teachers of ELA, history/social studies, science, and technical subjects using their content area expertise to help students meet the particular challenges of reading, writing, speaking, listening, and language in their respective fields. It is important to note that the 6–12 literacy standards in history/social studies, science, and technical subjects are not meant to replace content standards in those areas but rather support them.

The Standards also lay out a vision of what it means to be a literate person. The skills and understandings students are expected to demonstrate are not just for academic success but for real-world application. Students who meet the Standards are attentive readers who understand and enjoy complex works of literature and effective communicators who can express themselves in any setting. Students who meet the Standards develop the skills in reading, writing, speaking, and listening that are the foundation for any creative and purposeful expression in language, both in and outside the classroom or workplace.

The Science of Reading

The Iowa Department of Education recognizes the importance of the science of reading to support students in achieving the College and Career Readiness (CCR) Standards. The definition for the science of reading adopted by the Iowa Department of Education follows.

The Science of Reading is a vast body of research from multiple fields (i.e., education, linguistics, psychology, neuroscience) and derives from multiple studies that explain how individuals learn to read and the practices most effective in maximizing student literacy outcomes. This body of research informs the "what" and "how" of teaching literacy (reading and writing). It also informs the focus of teacher preparation programs, the instructional materials districts select, and the professional learning most likely to impact teaching and learning.

The Science of Reading is not a philosophy, a specific program, or a single method of teaching or component of instruction. While scientifically based reading research is supported by state (Lowa Code 279.68(2a)) and federal policy (Public Law 114-95), the Science of Reading is a nonpartisan topic; it is based on what is most effective in teaching reading and writing.

Shifts for College and Career Readiness Standards in English Language Arts/Literacy

Complexity

 The Standards ask students to practice regularly with complex text and its academic language to be ready for the demands of college and careers.

Evidence

• As students read, write, and speak, the Standards require the questions asked and the replies given to be grounded in evidence from literary and informational text.

Knowledge

- The Standards build students' knowledge through the use of content-rich nonfiction.
- Fulfilling the standards requires a balance of literary and informational text.

Key Design Considerations

College and Career Readiness (CCR) anchor standards

- Provide continuity for student learning within and across the standards.
- Define general, cross-disciplinary literacy expectations.
- Prepare students to enter college and workforce training programs ready to succeed.
- Blend research and media skills into the standards as a whole.
- Correspond with accompanying grade-specific standards, translating the broader CCR statement into grade-appropriate end-of-year expectations.

Grade-specific standards

- K-8 standards include individual standards for each anchor standard at each grade level.
- 9-12 standards use two-year bands (9-10) (11-12).
 - o Allow schools and districts flexibility in high school course design.
- Define end-of-year expectations.
- Cumulative progression designed to enable students to meet college and career readiness expectations no later than the end of high school.
- Students are expected to
 - o Meet each year's grade-specific standards.
 - Retain or further develop skills and understandings mastered in preceding grades.
 - Work steadily toward meeting the College and Career Readiness (CCR) standards.

A focus on results rather than means

 Standards leave room for teachers, curriculum developers, and schools to determine how the goals should be reached.

An integrated model of literacy

- Standards are divided into strands (reading, writing, speaking and listening, and language).
- Standards are not intended to be taught in isolation.

Focus and coherence in instruction and assessment

- Standards delineate specific expectations in reading, writing, speaking, listening, and language, though each standard need not be a separate focus for instruction and assessment.
- Several standards can be addressed by a single rich task.

Research and media skills blended into the Standards as a whole

 Conducting original research, students are to gather, comprehend, evaluate, synthesize, and report on information and ideas, solve problems, and analyze and create a range of print and nonprint text in media formats.

Shared responsibility for students' literacy development

- Interdisciplinary approach to literacy
 - K–5 standards
 - Include expectations for reading, writing, speaking, listening, and language applicable to a range of subjects, including but not limited to ELA.
 - 6-12 standards
 - Divided into two sections: one for ELA and the other for history/social studies, science, and technical subjects.
 - Each section is taught by teachers from varying content areas.
- Several standards can be addressed by a single rich task.
- Students can develop skills and exhibit mastery of standards for reading and writing across a range of texts.

Design Limitations of the Standards

The Standards cannot dictate or design comprehensive quality instruction. There are several design limitations to be considered:

- The Standards define what all students are expected to know and be able to do.
- The Standards do not determine how teachers should teach.
- The Standards are intended to be complemented by a well-developed, content-rich curriculum consistent with the expectations laid out in this document.
- The Standards are meant to articulate what is most essential, not to provide an exhaustive list or restrictions on what can be taught.
- The Standards do not define advanced work for students who meet the Standards.
- The Standards do not define intervention methods or materials for students well below or well above grade level.
- The Standards do not define the full range of support for English language learners.
- The Standards should also be read as allowing for the widest possible range of students to participate
 fully from the outset and as permitting appropriate scaffolding and accommodations to ensure
 maximum participation of students with special education needs.
- The Standards should be implemented within rigorous academic preparation across a wide variety of learning objectives and content areas.

Key Features of the Standards

Reading: Text complexity and the growth of comprehension

• Grade-by-grade "staircase" of increasing text complexity that rises from beginning reading to the college and career readiness level

Writing: Text types, responding to reading, and research

- Some writing skills are applicable to many types of writing
 - o the ability to plan, revise, edit, and publish
- Other skills are more properly defined in terms of specific writing types
 - o arguments, informative/explanatory texts, and narratives

Speaking and Listening: Flexible communication and collaboration

Require students to develop a range of oral communication and interpersonal skills

- Students learn to
 - work together
 - o express and listen carefully to ideas
 - o integrate information from oral, visual, quantitative, and media sources
 - evaluate what they hear
 - o use media and visual displays strategically to help achieve communicative purposes
 - o adapt speech to audience, context and task.

Language: Conventions, effective use, and vocabulary

- Include the essential "rules" of standard written and spoken English
- Approach language as a matter of craft and informed choice among alternatives
- Vocabulary standards focus on
 - o understanding words and phrases: relationships and nuances
 - acquiring and applying new vocabulary: general academic and domain-specific words and phrases

Distribution of Literary and Informational Text Types

The Standards aim to align instruction with this framework so that many more students than at present can meet the requirements of college and career readiness.

The 2022 and 2024 reading framework for the National Assessment of Educational Progress (NAEP)
requires a high and increasing proportion of informational text on its assessments as students advance
through the grades. The revised standards for English Language Arts are aligned with this framework,
equipping all students to meet these text complexity demands of college and career readiness.

It follows that writing assessments aligned with the Standards should adhere to the distribution of writing purposes across grades outlined by NAEP.

The 2017 NAEP outlines a distribution across the grades of the purposes and types of student writing.


How to Read This Document

Overall Document Organization

The Standards are organized into three main sections:

- A comprehensive K–5 section
- Two content area-specific sections for grades 6–12
 - o one for ELA
 - o one for history/social studies, science, and technical subjects

There are three appendices and one supplemental document accompanying the main document.



1. Each section listed above is divided into strands.

ELA – Literacy Strands - Grades K-12

- RL- Reading: Literature
- RI Reading: Informational Text
- RF Reading: Foundational Skills (K-5)
- WF Writing Foundational Skills (K-5)
- W Writing
- SL Speaking and Listening
- L Language

Additional Literacy Strands - Grades 6-12

- RH Reading: History/Social Studies
- RST Reading: Science and Technical Subjects
- WHST Writing: History/Social Studies, Science, and Technical Subjects
- 2. Standards for each grade follow the College and Career Readiness (CCR) Anchor Standards.
 - Each grade-specific standard corresponds to the same-numbered CCR anchor standard.
- 3. Individual standards can be identified by the code used above.
- 4. The Depth of Knowledge (DOK) is added to the end of the standard for clarity with academic rigor.

The Role and Importance of Cognitive Complexity

Reading DOK Levels

Reading Level 1

Requires students to

- Recite facts or use simple skills or abilities.
- Read with a basic comprehension of a text.
- Understand the text at a basic or shallow level.
 - o recall and support ideas using text evidence.
 - o paraphrase specific details from the text.
 - o understand single words or phrases.
- Use reference materials to find the meanings of words.
- Recognize figurative language in a reading passage.

Reading Level 2

Requires students to

- Engage in mental processing beyond basic recall or reproduction of a response, in addition to skills and concepts covered in Level 1.
- Comprehend and process a text or portion of text. Inter-sentence analysis of inference is required.
- Recognize important concepts, but not in a complex way. Literal main ideas are stressed.
- Summarize, interpret, infer, classify, organize, collect, display, compare, and determine whether fact or opinion.
- Develop a closer understanding of text, possibly through the item's paraphrasing of both the question and the answer.
- Use context cues to identify the meaning of unfamiliar words, phrases, and expressions that could otherwise have multiple meanings.
- Predict a logical outcome based on information in a reading selection.
- Identify and summarize the major events in a narrative.

Reading Level 3

Requires students to

- Develop text analysis skills, in addition to skills and concepts covered in Levels 1 and 2.
- Demonstrate an ability to go beyond the text while showing an understanding of the ideas in the text.
- Explain, generalize, or connect ideas.
- Develop and connect reasoning and planning.
- Demonstrate an ability to support their thinking. Items may involve abstract theme identification, inference across an entire passage, or application of prior knowledge. Items may also involve more superficial connections between texts.
- Explain or recognize how the author's purpose affects the interpretation of a reading selection.
- Summarize information from multiple sources to address a specific topic.
- Analyze and describe the characteristics of various types of literature.

Reading Level 4

Requires students to

- Develop higher-order thinking skills, in addition to skills and concepts covered in Levels 1, 2, and 3.
- Transfer information from at least one passage of a text and apply to a new task.
- Develop hypotheses and perform complex analyses of the connections among texts.
- Analyze and synthesize information from multiple sources.
- Examine and explain alternative perspectives across a variety of sources.
- Describe and illustrate how common themes are found across texts from different cultures.

Writing DOK Levels

Writing Level 1

Requires students to

- Write or recite simple facts. The focus of this writing or recitation is not on complex synthesis or analysis but on basic ideas.
- List ideas or words, as in a brainstorming activity, prior to written composition.
- Engage in a simple spelling or vocabulary assessment or write simple sentences.
- Write, speak, and edit using the conventions of Standard English (This includes using appropriate grammar, punctuation, capitalization, and spelling.)
- Demonstrate a basic understanding and appropriate use of such reference materials as a dictionary, thesaurus, or Web site.
- Apply the use of punctuation marks correctly.
- Identify Standard English grammatical structures, including the correct use of verb tenses.

Writing Level 2

Requires students to

- Develops mental processes in addition to skills and concepts covered in Level 1.
- Engage in first-draft writing or impromptu speaking for a limited number of purposes and audiences.
- Connect ideas using a simple organizational structure (e.g., note-taking, outlining, or simple summaries) (Text may be limited to one paragraph.)
- Construct or edit compound or complex sentences, with attention to the correct use of phrases and clauses.
- Use simple organizational strategies to structure written work.
- Write summaries containing the main idea of the reading selection and pertinent details.

Writing Level 3

Requires students to

- Use higher-level mental processing, in addition to skills and concepts covered in Levels 1 and 2.
- Engage in developing compositions that include multiple paragraphs.
- Develop compositions that include complex sentence structure and demonstrate some synthesis and analysis.
- Show awareness of their audience and purpose through focus, organization, and the use of appropriate compositional elements.
- Demonstrate the use of appropriate compositional elements, including addressing chronological order in a narrative or including supporting facts and details in an informational report.
- Engage in editing and revising to improve the quality of the composition.
 - Support ideas with details and examples.
 - Use voice appropriate to the purpose and audience.
 - Edit writing to produce a logical progression of ideas.

Writing Level 4

Requires students to:

- Apply higher-level thinking central to Level 4, in addition to skills and concepts covered in Levels 1, 2 and 3.
- Synthesize and analyze complex ideas or themes in multi-paragraph compositions.
- Demonstrate use and deep awareness of purpose and audience (e.g., informational papers include hypotheses and supporting evidence).
- Create compositions that demonstrate a distinct voice and stimulate the reader or listener to consider new perspectives on the ideas and themes addressed.
- Write an analysis of two selections, identifying the common theme and generating an appropriate purpose for both.

Standard 10: Range, Quality, and Complexity of Student Reading

Measuring Text Complexity: A Three-part Model

As the graphic below indicates, the Standards' model of text complexity consists of three equally important parts.

Qualitative dimensions of text complexity:

- Aspects measured by an attentive human reader
 - meaning or purpose
 - structure
 - language conventionality and clarity
 - o knowledge demands

Quantitative dimensions of text complexity:

- Aspects measure for readability typically by computer software
 - word length or frequency
 - o sentence length
 - text cohesion

Reader and task considerations:

- Reader and task variables that impact text complexity
 - o previous knowledge and experiences
 - o assigned task
 - o questions posed

Students Who are College and Career Ready in Reading, Writing, Speaking, Listening, and Language

The following descriptions are not standards but offer a portrait of students who meet the standards set out in this document.

They demonstrate independence.

- Students can, without significant scaffolding, comprehend and evaluate complex texts across a range
 of types and disciplines.
- Students can construct effective arguments and convey intricate or multifaceted information.
- Students can independently discern a speaker's key points, request clarification, and ask relevant questions.
- Students can build on others' ideas, articulate their own ideas, and confirm that they have been understood.
- Students can demonstrate command of standard English and acquire and use a wide-ranging vocabulary.
- Students become self-directed learners, effectively seeking out and using resources to assist them, including teachers, peers, and print and digital reference materials.

They build strong content knowledge.

- Students establish a knowledge base across a wide range of subject matter by engaging with works of quality and substance.
- Students become proficient in new areas through research and study.
- Students read purposefully and listen attentively to gain general knowledge and discipline-specific expertise.
- Students refine and share their knowledge through writing and speaking.

They respond to the varying demands of audience, task, purpose, and discipline.

- Students adapt their communication in relation to audience, task, purpose, and discipline.
- Students set and adjust purpose for reading, writing, speaking, listening, and language use as warranted by the task.
- Students appreciate nuances, such as how the composition of an audience should affect tone when speaking and how the connotations of words affect meaning.
- Students know that different disciplines call for different types of evidence (e.g., documentary evidence in history, experimental evidence in science).

They comprehend as well as critique.

- Students are engaged and open-minded—but discerning—readers and listeners.
- Students work diligently to understand what an author or speaker is saying precisely.
- Students question an author's or speaker's assumptions and premises and assess the veracity of claims and the soundness of reasoning.

They value evidence.

- Students cite specific evidence when offering an oral or written interpretation of a text.
- Students use relevant evidence when supporting their points in writing and speaking, making their reasoning clear to the reader or listener.
- Students constructively evaluate others' use of evidence.

They use technology and digital media strategically and capably.

- Students employ technology thoughtfully to enhance their reading, writing, speaking, listening, and language use.
- Students tailor their searches online to acquire useful information efficiently.
- Students integrate what they learn using technology with what they learn offline.
- Students are familiar with the strengths and limitations of various technological tools and mediums.
- Students can select and use those best suited to their communication goals.

They come to understand other perspectives and cultures.

- Students appreciate that the twenty-first-century classroom and workplace are settings where people from often widely divergent cultures, representing diverse experiences and perspectives, must learn and work together.
- Students actively seek to understand other perspectives and cultures through reading and listening.
- Students can communicate effectively with people of varied backgrounds.
- Students evaluate other points of view critically and constructively.
- Students can vicariously inhabit worlds and have experiences much different than their own through reading great classic and contemporary works of literature representative of a variety of periods, cultures, and worldviews.

Standards for English Language Arts (K-5)

College and Career Readiness Anchor Standards for Reading

The K–5 standards on the following pages define what students should understand and be able to do by the end of each grade. They correspond to the College and Career Readiness (CCR) anchor standards below by number. The CCR and grade-specific standards are necessary complements—the former providing broad standards, the latter providing additional specificity—that together define the skills and understandings that all students must demonstrate.

Key Ideas and Details

- 1. Read closely to determine what the text says explicitly and to make logical inferences from it; cite specific textual evidence when writing or speaking to support conclusions drawn from the text.
- 2. Determine central ideas or themes of a text and analyze their development; summarize the key supporting details and ideas
- 3. Analyze how and why individuals, events, and ideas develop and interact over the course of a text.

Craft and Structure

- 4. Interpret words and phrases as they are used in a text, including determining technical, connotative, and figurative meanings, and analyze how specific word choices shape meaning or tone.
- Analyze the structure of texts, including how specific sentences, paragraphs, and larger portions of the text (e.g., a section, chapter, scene, or stanza) relate to each other and the whole.
- 6. Assess how point of view or purpose shapes the content and style of a text.

Integration of Knowledge and Ideas

- 7. Integrate and evaluate content presented in diverse media and formats, including visually and quantitatively, as well as in words.*
- 8. Delineate and evaluate the argument and specific claims in a text, including the validity of the reasoning as well as the relevance and sufficiency of the evidence.
- 9. Analyze how two or more texts address similar themes or topics in order to build knowledge or to compare the approaches the authors take.

Range of Reading and Level of Text Complexity

10. Read and comprehend complex literary and informational texts independently and proficiently.

Note on range and content of student reading

To build a foundation for college and career readiness, students must read widely and deeply from among a broad range of high-quality, increasingly challenging literary and informational texts. Through extensive reading of stories, dramas, poems, and myths and exposure to visual media from diverse cultures and different time periods, students gain literary and cultural knowledge as well as familiarity with various text structures and elements. By reading texts in history/social studies, science, and other disciplines, students build a foundation of knowledge in these fields that will also give them the background to be better readers in all content areas. Students can only gain this foundation when the curriculum is intentionally and coherently structured to develop rich content knowledge within and across grades. Students also acquire the habits of reading independently and closely, which are essential to their future success.

Reading Standards for Literature K-5

The following standards offer a focus for instruction each year and help ensure that students gain adequate exposure to a range of texts and tasks. Rigor is also infused through the requirement that students read increasingly complex texts through the grades. Students advancing through the grades are expected to meet each year's grade-specific standards and retain or further develop skills and understandings mastered in preceding grades.

Kindergarten

Key Ideas and Details

Reading and Writing Standards: Foundational Skills (K-5)

These standards are directed toward fostering students' understanding and working knowledge of concepts of print, the alphabetic principle, and other basic conventions of the English writing system. These foundational skills are not an end in and of themselves; rather, they are necessary and important components of an effective, comprehensive reading program designed to develop proficient readers with the capacity to comprehend texts across a range of types and disciplines. Instruction should be differentiated: good readers will need much less practice with these concepts than struggling readers will. The point is to teach students what they need to learn and not what they already know—to discern when particular children or activities warrant more or less attention.

Note: In kindergarten, children are expected to demonstrate increasing awareness and competence in the areas that follow.

Note on range and content of student writing

To build a foundation for college and career readiness, students need to use writing as a tool for learning and communicating to offer and support opinions, demonstrate understanding of the subjects they are studying, and convey real and imagined experiences and events. They learn to appreciate that a key purpose of writing is to communicate clearly to an external, sometimes unfamiliar audience, and they begin to adapt the form and content of their writing to accomplish a particular task and purpose. They develop the capacity to build knowledge on a subject through research projects and to respond analytically to literary and informational sources. To meet these goals, students must devote significant time and effort to writing, producing numerous pieces over short and extended time frames throughout the year.

Writing Standards K-5

The following standards for K–5 offer a focus for instruction each year to help ensure that students gain adequate mastery of a range of skills and applications. Each year in their writing, students should demonstrate increasing sophistication in all aspects of language use, from vocabulary and syntax to the development and organization of ideas, and they should address increasingly demanding content and sources. Note on range and content of student speaking and listening

To build a foundation for college and career readiness, students must have ample opportunities to take part in a variety of rich. structured conversations—as part of a whole class, in small groups, and with a partner. Being productive members of these conversations requires that students contribute accurate, relevant information; respond to and develop what others have said: make comparisons and contrasts; and analyze and synthesize a multitude of ideas in various domains.

New technologies have broadened and expanded the role that speaking and listening play in acquiring and sharing knowledge and have tightened their link to other forms of communication. Digital texts confront students with the potential for continually updated content and dynamically changing combinations of words, graphics, images, hyperlinks, and embedded video and audio.

Note on range and content of student language use

To build a foundation for college and career readiness in language, students must gain control over many conventions of standard English grammar. usage, and mechanics as well as learn other ways to use language to convey meaning effectively. They must also be able to determine or clarify the meaning of grade-appropriate words encountered through listening, reading, and media use; come to appreciate that words have nonliteral meanings. shadings of meaning, and relationships to other words; and expand their vocabulary in the course of studying content. The inclusion of Language standards in their own strand should not be taken as an indication that skills related to conventions, effective language use, and vocabulary are unimportant to reading. writing, speaking, and listening; indeed, they are inseparable from such contexts.

Note on range and content of student reading

Along with high-quality contemporary works, these texts should be chosen from among seminal U.S. documents, the classics of American literature, and the timeless dramas of Shakespeare. Through wide and deep reading of literature and literary nonfiction and thoughtful exposure to visual media of steadily increasing sophistication, students gain a reservoir of literary and cultural knowledge, references, and images; the ability to evaluate intricate arguments; and the capacity to surmount the challenges posed by complex texts.

The grades 6–12 standards on the following pages define what students should understand and be able to do by the end of each grade. They correspond to the College and Career Readiness (CCR) anchor standards below by number. The CCR and grade-specific standards are necessary complements—the former providing broad standards, the latter providing additional specificity—that together define the skills and understandings that all students must demonstrate.

Text Types and Purposes*

- 1. Write arguments to support claims in an analysis of substantive topics or texts, using valid reasoning and relevant and sufficient evidence.
- 2. Write informative/explanatory texts to examine and convey complex ideas and information clearly and accurately through the effective selection, organization, and analysis of content.
- 3. Write narratives to develop real or imagined experiences or events using effective technique, well-chosen details, and well-structured event sequences.

Production and Distribution of Writing

- 4. Produce clear and coherent writing in which the development, organization, and style are appropriate to task, purpose, and audience.
- 5. Develop and strengthen writing as needed by planning, revising, editing, rewriting, or trying a new approach.
- 6. Use technology, including the Internet, to produce and publish writing and to interact and collaborate with others.

Research to Build and Present Knowledge

- 7. Conduct short as well as more sustained research projects based on focused questions, demonstrating understanding of the subject under investigation.
- 8. Gather relevant information from multiple print and digital sources, assess the credibility and accuracy of each source, and integrate the information while avoiding plagiarism.
- 9. Draw evidence from literary or informational texts to support analysis, reflection, and research.

Range of Writing

10. Write routinely over extended time frames (time for research, reflection, and revision) and shorter time frames (a single sitting or a day or two) for a range of tasks, purposes, and audiences.

Note on range and content of student writing

For students, writing is a key means of asserting and defending claims, showing what they know about a subject, and conveying what they have experienced, imagined, thought, and felt. To be college- and career-ready writers, students must take task, purpose, and audience into careful consideration, choosing words, information, structures, and formats deliberately. They need to know how to combine elements of different kinds of writing—for example, to use narrative strategies within argument and explanation within narrative—to produce complex and nuanced writing. They need to be able to use technology strategically when creating. refining, and collaborating on writing and visual media. They have to become adept at gathering information, evaluating sources, and citing material accurately, reporting findings from their research and analysis of sources in a clear and cogent manner. They must have the flexibility, concentration, and fluency to produce high-quality first draft text under a tight deadline as well as the capacity to revisit and make improvements to a piece of writing over multiple drafts when circumstances encourage or require it.

Writing Standards 6–12

The following standards for grades 6–12 offer a focus for instruction each year to help ensure that students gain adequate mastery of a range of skills and applications. Each year in their writing, students should demonstrate increasing sophistication in all aspects of language use, from vocabulary and syntax to the development and organization of ideas, and they should address increasingly demanding content and sources. Students advancing through the grades are expected to meet each year's grade-specific standards and retain or further develop skills and understandings mastered in preceding grades. The expected growth in student writing ability is reflected both in the standards themselves and in the collection of annotated student writing samples in Appendix C.

Grade 6

- 1. Write arguments to support claims with clear reasons and relevant evidence.

The grades 6–12 standards on the following pages define what students should understand and be able to do by the end of each grade. They correspond to the College and Career Readiness (CCR) anchor standards below by number. The CCR and grade-specific standards are necessary complements—the former providing broad standards, the latter providing additional specificity—that together define the skills and understandings that all students must demonstrate.

Comprehension and Collaboration

- 1. Prepare for and participate effectively in a range of conversations and collaborations with diverse partners, building on others' ideas and expressing their own clearly and persuasively.
- 2. Integrate and evaluate information presented in diverse media and formats, including visually, quantitatively, and orally.
- 3. Evaluate a speaker's point of view, reasoning, and use of evidence and rhetoric.

Presentation of Knowledge and Ideas

- 4. Present information, findings, and supporting evidence such that listeners can follow the line of reasoning and the organization, development, and style are appropriate to task, purpose, and audience.
- 5. Make strategic use of digital media and visual displays of data to express information and enhance understanding of presentations.
- Adapt speech to a variety of contexts and communicative tasks, demonstrating command of formal English when indicated or appropriate.

Note on range and content of student speaking and listening

To become college and career ready, students must have ample opportunities to take part in a variety of rich, structured conversations—as part of a whole class, in small groups, and with a partner—built around important content in various domains. They must be able to contribute appropriately to these conversations, to make comparisons and contrasts, and to analyze and synthesize a multitude of ideas in accordance with the standards of evidence appropriate to a particular discipline. Whatever their intended major or profession, high school graduates will depend heavily on their ability to listen attentively to others so that they are able to build on others' meritorious ideas while expressing their own clearly and persuasively.

New technologies have broadened and expanded the role that speaking and listening play in acquiring and sharing knowledge and have tightened their link to other forms of communication. The Internet has accelerated the speed at which connections between speaking, listening, reading, and writing can be made, requiring that students be ready to use these modalities nearly simultaneously. Technology itself is changing quickly, creating a new urgency for students to be adaptable in response to change.

Speaking and Listening Standards 6–12

The following standards for grades 6–12 offer a focus for instruction in each year to help ensure that students gain adequate mastery of a range of skills and applications. Students advancing through the grades are expected to meet each year's grade-specific standards and retain or further develop skills and understandings mastered in preceding grades. The CCR anchor standards and high school grade-specific standards work in tandem to define college and career readiness expectations—the former providing broad standards, the latter providing additional specificity.

Grade 6

Comprehension and Collaboration

- 1. Engage effectively in a range of collaborative discussions (one-on-one, in groups, and teacher-led) with diverse partners on *grade 6 topics, texts, and issues*, building on others' ideas and expressing their own clearly.

Note on range and content of student language use

To build a foundation for college and career readiness in language, students must gain control over many conventions of standard English grammar. usage, and mechanics as well as learn other ways to use language to convey meaning effectively. They must also be able to determine or clarify the meaning of grade-appropriate words encountered through listening, reading, and media use; come to appreciate that words have nonliteral meanings. shadings of meaning, and relationships to other words; and expand their vocabulary in the course of studying content. The inclusion of Language standards in their own strand should not be taken as an indication that skills related to conventions, effective language use, and vocabulary are unimportant to reading. writing, speaking, and listening; indeed, they are inseparable from such contexts.

Language Standards 6-12

Note on range and content of student reading

Content area literacy is critical to students' post secondary success in higher education and the workplace. To prepare students for these challenges, literacy skills must to be developed across all content areas. Students expand their range when applying literacy skills to a variety of content areas because the academic discourses and disciplinary concepts in those require different approaches to reading, writing, speaking, viewing, and listening. It is through applying literacy skills in a number of content areas that students learn to integrate these skills and strategies into life experience. Teachers in all content areas who make literacy a priority understand that learning involves making meaning.

Note on range and content of student writing

For students, writing is a key means of asserting and defending claims, showing what they know about a subject, and conveying what they have experienced, imagined, thought, and felt. To be college and career ready writers, students must take task, purpose, and audience into careful consideration, choosing words, information, structures, and formats deliberately. They need to be able to use technology strategically when creating, refining, and collaborating on writing. They have to become adept at gathering information. evaluating sources, and citing material accurately, reporting findings from their research and analysis of sources in a clear and cogent manner. They must have the flexibility, concentration, and fluency to produce high-quality first draft text under a tight deadline and the capacity to revisit and make improvements to a piece of writing over multiple drafts when circumstances encourage or require it. To meet these goals. students must devote significant time and effort to writing, producing numerous pieces over short and long time frames throughout the year.

Range of Writing

10. Write routinely over extended time frames (time for research, reflection, and revision) and shorter time frames (a single sitting or a day or two) for a range of tasks, purposes, and audiences.

The CCR anchor standards and high school standards in literacy work in tandem to define college and career readiness expectations—the former providing broad standards, the latter providing additional specificity.

Grades 6-8

Text Types and Purposes

- 1. Write arguments focused on discipline-specific content.
 - a. Introduce claim(s) about a topic or issue, acknowledge and distinguish the claim(s) from alternate or opposing claims, and organize the reasons and evidence logically.
 - b. Support claim(s) with logical reasoning and relevant, accurate data and evidence that demonstrate an understanding of the topic or text, using credible sources.
 - c. Use words, phrases, and clauses to create cohesion and clarify the relationships among claim(s), counterclaims, reasons, and evidence.
 - d. Establish and maintain a formal style appropriate for the task and audience.
 - e. Provide a concluding statement or section that follows and supports the argument presented. (WHST.6-8.1)
- 2. Write informative/explanatory texts, including the narration of historical events, scientific procedures/experiments, or technical processes.
 - a. Introduce a topic clearly, previewing what is to follow; organize ideas, concepts, and information into broader categories as appropriate to achieving purpose; include formatting (e.g., headings), graphics (e.g., charts, tables), and multimedia when useful to aiding comprehension.
 - b. Develop the topic with relevant, well-chosen facts, definitions, concrete details, quotations, or other information and examples.
 - c. Use appropriate and varied transitions to create cohesion and clarify the relationships among ideas and concepts.
 - d. Use precise language and domain-specific vocabulary to inform about or explain the topic.
 - e. Establish and maintain a formal style and objective tone appropriate for the task and audience.
 - f. Provide a concluding statement or section that follows and supports the information or explanation presented. (WHST.6-8.2)
- 3. (See note; not applicable as a separate requirement) (WHST.6-8.3)

Production and Distribution of Writing

- 4. Produce clear and coherent writing in which the development, organization, and style are appropriate to task, purpose, and audience. (WHST.6-8.4)
- 5. With some guidance and support from peers and adults, develop and strengthen writing as needed by planning, revising, editing, rewriting, or trying a new approach, focusing on how well purpose and audience have been addressed. (WHST.6-8.5)
- 6. Use technology to produce and publish writing to interact and collaborate with others through a variety of media to present the relationships between information and ideas efficiently. (WHST.6-8.6)

 - d. Establish and maintain a formal style and objective tone while attending to the norms and conventions of the discipline.
 - e. Provide a concluding statement or section that follows from or supports the argument presented. (WHST.9-10.1)
- 2. Write informative/explanatory texts, including the narration of historical events, scientific procedures/experiments, or technical processes.
 - a. Introduce a topic and organize ideas, concepts, and information to make important connections and distinctions; include formatting (e.g., headings), graphics (e.g., figures, tables), and multimedia when useful to aiding comprehension.
 - b. Develop the topic with well-chosen, relevant, and sufficient facts, extended definitions, concrete details, quotations, or other information and examples appropriate to the audience's knowledge of the topic.
 - c. Use varied transitions and sentence structures to link the major sections of the text, create cohesion, and clarify the relationships among ideas and concepts.
 - d. Use precise language and domain-specific vocabulary to manage the complexity of the topic and convey a style appropriate to the discipline and context as well as to the expertise of likely readers.
 - e. Establish and maintain a formal style and objective tone while attending to the norms and conventions of the discipline in which they are writing.
 - f. Provide a concluding statement or section that follows from and supports the information or explanation presented (e.g., articulating implications or the significance of the topic). (WHST.9-10.2)
- 3. (See note; not applicable as a separate requirement) (WHST.9-10.3)

Production and Distribution of Writing

- 4. Produce clear and coherent writing in which the development, organization, and style are appropriate to task, purpose, and audience. (WHST.9-10.4)
- 5. Develop and strengthen writing as needed by planning, revising, editing, rewriting, or trying a new approach, focusing on addressing what is most significant for a specific purpose and audience. (WHST.9-10.5)
- 6. Use technology to produce, publish, and update individual or shared writing products, taking advantage of technology's capacity to link to other information and to display information flexibly and dynamically. (WHST.9-10.6)

Research to build and Present Knowledge

- 7. Conduct short as well as more sustained research projects to answer a question (including a self generated question) or solve a problem; narrow or broaden the inquiry when appropriate; synthesize multiple sources on the subject, demonstrating understanding of the subject under investigation. (WHST.9-10.7)

Gather relevant information from multiple credible primary and secondary print and digital sources, using advanced searches effectively; assess the usefulness of each source including recognition of bias in answering the research question; integrate information into the text selectively to maintain the flow of ideas, avoiding plagiarism and following a standard format for citation.  - a. Introduce precise, knowledgeable claim(s), establish the significance of the claim(s), distinguish the claim(s) from alternate or opposing claims, and create an organization that logically sequences the claim(s), counterclaims, reasons, and evidence.
 - Develop claim(s) and counterclaims, supplying the most relevant data and evidence for each in a discipline-appropriate form that anticipates the audience's knowledge level, concerns, values, and possible biases.
 - c. Use words, phrases, and clauses as well as varied syntax to link the major sections of the text, create cohesion, and clarify the relationships between claim(s) and reasons, between reasons and evidence, and between claim(s) and counterclaims.
 - d. Establish and maintain a formal style and objective tone while attending to the norms and conventions of the discipline.
 - e. Provide a concluding statement or section that follows from or supports the argument presented by summarizing main points. (WHST.11-12.1)
- 2. Write informative/explanatory texts, including the narration of historical events, scientific procedures/experiments, or technical processes.
 - a. Introduce a topic and organize complex ideas, concepts, and information so that each new element builds on that which precedes it to create a unified whole; include formatting (e.g., headings), graphics (e.g., figures, tables), and multimedia when useful to aiding comprehension.
 - b. Develop the topic clearly and thoroughly by selecting the most significant and relevant facts, extended definitions, concrete details, quotations, or other information and examples appropriate to the audience's knowledge of the topic.
 - c. Use varied transitions and sentence structures to link the major sections of the text, create cohesion, and clarify the relationships among complex ideas and concepts.
 - d. Use precise language, domain-specific vocabulary and techniques, such as figures of speech or text structure, to manage the complexity of the topic; convey a knowledgeable stance in a style that responds to the discipline and context as well as to the expertise of likely readers.
 - e. Provide a concluding statement or section that follows from and supports the information or explanation provided that includes articulating implications or the significance of the topic. (WHST.11-12.2)
- 3. (See note; not applicable as a separate requirement) (WHST.11-12.3)

Production and Distribution of Writing

- 4. Produce clear and coherent writing in which the development, organization, and style are appropriate to task, purpose, and audience. (WHST.11-12.4)
- 5. Develop and strengthen writing as needed by planning, revising, editing, rewriting, or trying a new approach, focusing on addressing what is most significant for a specific purpose and audience. (WHST.11-12.5)
- 6. Use technology to produce, publish, and update individual or shared writing products in response to ongoing feedback, including new arguments or information. (WHST.11-12.6)

Research to build and Present Knowledge

- 7. Conduct short as well as more sustained research projects to answer a question (including a self generated question) or solve a problem; narrow or broaden the inquiry when appropriate; synthesize multiple sources on the subject, demonstrating understanding of the subject under investigation. (WHST.11-12.7)
- 8. Gather relevant information from multiple credible primary and secondary print and digital sources, using advanced searches effectively; assess the strengths and limitations of each source in terms of the specific task, purpose, and audience, including recognition of bias; integrate information into the text selectively to maintain the flow of ideas, avoiding plagiarism and overreliance on any one source and following a standard format for citation. (WHST.11-12.8)
- 9. Draw evidence from informational texts to support analysis, reflection, and research. (WHST.11-12.9)

Range of Writing

10. Write routinely over extended time frames (time for reflection and revision) and shorter time frames (a single sitting or a day or two) for a range of discipline-specific tasks, purposes, and audiences. (WHST.11-12.10)

Note: Students' narrative skills continue to grow 6-12. The Standards require that students be able to incorporate narrative elements effectively into arguments and informative/explanatory texts. In history/social studies, students must be able to incorporate narrative accounts into their analyses of individuals or events of historical import. In science and technical subjects, students must be able to write precise enough descriptions of the step-by-step procedures they use in their investigations or technical work that others can replicate them and (possibly) reach the same results.
