Motion: Nathan Peterson made a motion and Cassandra Halls seconded to approve the Prairie Lakes AEA budget.


Vote: The ayes were unanimous. The motion carried.

Revision of Iowa Academic Standards for Mathematics


Motion: Mary Meisterling made a motion and Nathan Peterson seconded to approve the Revision of Iowa Academic Standards for Mathematics.
